## ADVICE NOTES FOR APPLICANTS

- 1 It is recommended that you obtain and become familiar with the Process Guidance Note "Waste Oil Burners, less than 0.4 MW Net Rated Thermal Input" PG 1/1 (95) which is relevant to the process for which the authorisation is sought. - 2 The applicant may supply any other information he wishes the Council to take into account in considering his application.
- 3 The purpose is to provide both a simple map and a plan to show the Council and members of the public, the location and layout of the premises which the process will occupy. This should show the process boundary, the location of stacks and vents, and in simple cases may be achieved on one map.
- 4 A person who knowingly provides false information in respect of this application is liable on summary conviction to a fine not exceeding £20,000 or on indictment to a fine or imprisonment of not more than two years or both.
