

**THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (YAZOR BROOK FLOOD ALLEVIATION SCHEME) COMPULSORY
PURCHASE ORDER 2010**

THE TOWN AND COUNTRY PLANNING ACT 1990

THE LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976

AND THE ACQUISITION OF LAND ACT 1981

The County of Herefordshire District Council (in this order called "the acquiring authority") makes the following order:

1. Subject to the provisions of this order, the acquiring authority is under section 226(1)(a) of the Town and Country Planning Act 1990 and section 13 of the Local Government (Miscellaneous Provisions) Act 1976 hereby authorised to purchase compulsorily the land and the new rights over land described in paragraph 2 for the purpose of facilitating the carrying out of development, re-development or improvement of the land for the provision of the Yazor Brook flood alleviation scheme which will allow the regeneration of the Edgar Street Grid area in Hereford, to include a new Link Road, and the provision of a Retail Quarter and an Urban Village and the associated infrastructure.
2. (1) The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in the County of Herefordshire District Council (Yazor Brook Flood Alleviation Scheme) Compulsory Purchase Order 2010".

(2) The new rights to be purchased compulsorily over land under this order are described in the Schedule and the land is shown coloured blue on the said map.

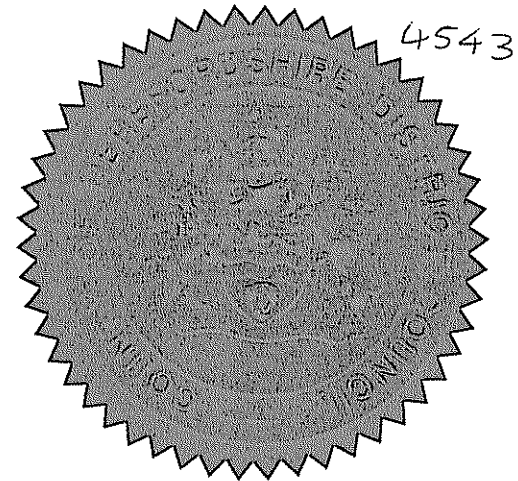
