

## The Commons Act 2006 Section 22: Schedule 2, paragraph 2 (to register land as common land)

Notice is hereby given that an application has been made by The Open Spaces Society to The County of Herefordshire District Council as Commons Registration Authority, concerning land adjacent to CL85 Broadmoor Common described more fully below.

A summary of the effect of the application is as follows:

The land was not at any time finally registered as common land or as a town or village green under the 1965 Act; the land is otherwise recognised or designated as common land by or under an enactment; and is land to which this section applies.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by registering the land in the register of common land.
