ROAD TRAFFIC REGULATION ACT 1984

(A438 NEWMARKET STREET AND BLUE SCHOOL STREET EAST BOUND AND WEST BOUND CARRIAGEWAYS AND B4359 WIDEMARSH STREET HEREFORD)
(RESTRICTED PARKING ZONE, PROHIBITION OF WAITING, LOADING AND UNLOADING AT ANY TIME) ORDER 2014

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under sections 1 and 2 of the Road Traffic Regulation Act 1984 (referred to as "the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order shall come into operation on the day of April 2014 and may be cited as the Herefordshire Council (A438 Newmarket Street and Blue School Street East Bound and West Bound Carriageways and B4359 Widemarsh Street, Hereford) (Restricted Parking Zone, Prohibition of Waiting, Loading and Unloading at Any Time) Order 2014
- 2. (1) In this Order:-
 - "Civil Enforcement Officer" means a person appointed in accordance with the provisions of Section 76 of the Traffic Management Act 2004.
- 3. Save as provided in Article 4 of this Order no person shall, except upon the direction or with the permission of a police officer or Civil Enforcement Officer in uniform, cause or permit any vehicle to wait, load and unload at any time on the lengths of road as mentioned in the Schedule hereto and as shown for identification purposes only on the attached plan.
- 4. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait in those lengths of road referred to in the said Article 3 for so long as may be necessary to enable:-
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used for the delivery or removal of plant/or materials for any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the side of those lengths of road referred to, or the laying, erection, alteration or repair in or near the said sides of those lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Communications Act 2003 (as amended);
 - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
 - (e) a public service vehicle waiting at an authorised stopping place to allow passengers to board or alight.
 - (f) the vehicle to be used for fire brigade, police or ambulance purposes.
 - (g) the vehicle to be used for the purposes of collecting waste or recyclables or street cleansing.
 - (h) a pedal cycle to be parked at a recognised pedal cycle stand.
- 5. The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.
- 6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the provisions in the following traffic regulation order that relate to the lengths of road subject to this Order which are in operation prior to the date mentioned in Article 1 hereto will be revoked in their entirety from the date mentioned in the said

Article 1.



SCHEDULE

Restricted Parking Zone, Prohibition of Waiting, Loading and Unloading at Any Time

A438 Newmarket Street and Blue School Street (East Bound Carriageway) North and south sides between a point 232 metres west of where the centre line of the B4349 Widemarsh Street (North) intersects the centre line of the A438 and a point 18 metres east of where the centre line of the B4349 Widemarsh Street (North) intersects the centre line of the A438.

A438 Newmarket Street and Blue School Street (West Bound Carriageway) North and south sides between a point 184 metres west of where the centre line of the U80000 Widemarsh Street (South) intersects the centre line of the A438 and a point 25 metres east of where the centre line of the U80000 Widemarsh Street (South) intersects the centre line of the A438.

B4359 Widemarsh Street (North) East and west sides from its junction with the northern kerb line of the A438 to a point 22 metres north of the said junction.
