

**THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL
(HEREFORD CITY CENTRE) (AMENDMENT 1) ORDER 2018**

The Council in exercise of its powers under Sections 1, 2, 4, 32(1), 35(1), and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the 1984 Act”), Section 63 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

CITATION AND COMMENCEMENT

- 1 This Order shall come into operation on the **[[DATE]]** and may be cited as The County of Herefordshire District Council (Hereford City Centre) (Amendment 1) Order 2018.

INTERPRETATION

- 2 In this Order:
 - (a) except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (b) any reference to an Act, Statutory Instrument, Regulation or Order shall be construed as a reference to that Act, Statutory Instrument or Order as amended.
 - (c) “Principal Order” shall mean The County of Herefordshire District Council (Hereford City Centre) Order 2017.

AMENDMENTS

- 9 The contents of Schedule 7 shall be deleted from Schedule 15 of the Principal Order.
- 10 The contents of Schedule 8 shall be inserted into Schedule 15 of the Principal Order.
- 11 The contents of Schedule 9 shall be deleted into Schedule 16 of the Principal Order.
