HIGHWAYS ACT 1980

AND

ACQUISITION OF LAND ACT 1981

Notice is hereby given that Public Local Inquiries in connection with the Orders mentioned below will be held by an Inspector, appointed for the purpose by the Secretary of State for Transport beginning at 10.00 am on Tuesday 30 October 2018 for 7 days, at the Bridge Room, Hereford Left Bank, Bridge Street, Hereford HR4 9DG to hear representations from remaining objectors as defined in the Compulsory Purchase (Inquiries Procedure) Rules 2007 and statutory objectors as defined in the Highways (Inquiries Procedure) Rules 1994, from any other persons having an interest in the land the subject of the Compulsory Purchase Order and, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

The Orders are Orders which have been made by The County of Herefordshire District Council under the above-mentioned Acts and submitted to the Secretary of State for Transport for confirmation and are:-

**THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (SOUTH WYE TRANSPORT PACKAGE) – A4194 SOUTHERN LINK ROAD (CLASSIFIED ROAD) (SIDE ROADS) ORDER 2018**

This is an Order under sections 14 and 125 of the Highways Act 1980, which, if confirmed, will authorise Herefordshire District Council to:

- a) improve highways (including raising, lowering or otherwise altering);
- b) stop up highways;
- c) construct new highways;
- d) stop up private means of access to premises; and
- e) provide new means of access to said premises,

all on or in the vicinity of the route of the classified road known as the A4194 Southern Link Road which the Council is proposing to construct between the A49 (Ross Road)/B4399 (Rotherwas Access Road) roundabout and the A465 (Abergavenny Road) and between the A465 (Abergavenny Road) and the B4349 (Clehonger Road) in the Parishes of Clehonger and Haywood Group.

**THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (SOUTH WYE TRANSPORT PACKAGE) – A4194 SOUTHERN LINK ROAD COMPULSORY PURCHASE ORDER 2018**

This is an Order under sections 239, 240, 246, 250 and 260 of the Highways Act 1980, which, if confirmed, will authorise Herefordshire District Council to purchase

compulsorily the land and new rights over the land described therein, for the purposes of:-

- a) the construction of a new highway between the A49 (Ross Road)/B4399 (Rotherwas Access Road) roundabout and the A465 (Abergavenny Road) and between the A465 (Abergavenny Road) and the B4349 (Clehonger Road) in the Parishes of Clehonger and Callow and Haywood Group;
- b) the construction of other highways and improvement of existing highways in the vicinity of the route of the above mentioned highway in pursuance of the County of Herefordshire District Council (South Wye Transport Package – A4194 Southern Link Road) (Classified Road) (Side Roads) Order 2018;
- c) the provision of new means of access to premises in pursuance of the County of Herefordshire District Council (South Wye Transport Package – A4194 Southern Link Road) (Classified Road) (Side Roads) Order 2018;
- d) the diversion of watercourses and the carrying out of other works on watercourses in connection with the construction and improvement of highways and the provision of new means of access to premises as aforesaid;
- e) the use by the acquiring authority in connection with the construction and improvement of highways and the provision of new means of access to premises aforesaid;
- f) the carrying out of drainage works in connection with the construction of the highways; and
- g) mitigating the adverse effect which the existence or use of the highways proposed to be constructed or improved will have on the surroundings thereof.

Copies of the above-mentioned Orders and of the plans referred to therein have been deposited and may be seen at all reasonable hours free of charge at the offices of the County of Herefordshire District Council, Blueschool House, Blueschool Street, Hereford HR1 2LX.

Copies of any proofs of evidence, sent to or by the promoting authority, are also available for inspection, at the addresses given above from 09 October 2018.

Proceedings on the above-mentioned Orders are being taken concurrently by virtue of Section 257 of the Highways Act 1980.
