This Order will come into operation on 15 February 2019.

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under section 84 of the Road Traffic Regulation Act of 1984 (referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. This Order shall come into operation on 15 February 2019 and may be cited as "Herefordshire Council (B4224 Hampton Bishop) (50 mph speed limit) Order 2019".
- 2. No person shall drive a motor vehicle at a speed exceeding 50 miles per hour along the following length of road:

B4224, Hampton Bishop

Between a point 152 metres northwest of its junction with the centre line of the U72203 Whitehall Road and a point 232 metres southeast of it junction with the centre line of the U72201 Church Lane.


