This required the revocation of the County of Hereford and Worcester (Restricted Roads) (No 6) Order 1987

The Order shall come into operation on 21 June 2019 and may be cited as Herefordshire Council (B4214, Tenbury Road, Bromyard) (30 mph and 40 mph Speed Limit) Order 2019.

HEREFORDSHIRE COUNCIL (B4214, TENBURY ROAD, BROMYARD) (30 MPH AND 40 MPH SPEED LIMIT) ORDER 2019

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under Section 84 of the Road Traffic Regulation Act of 1984 (referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. The Order shall come into operation on **21** Jone 2019 and may be cited as "Herefordshire Council (B4214, Tenbury Road, Bromyard) (30 mph and 40 mph Speed Limit) Order 2019".
- 2. No person shall drive a motor vehicle at a speed exceeding 30 miles per hour along the following length of road:

B4214, Tenbury Road, Bromyard

- a) From a point 41 metres southeast of the centre line of the junction with the U65438 Porthouse Industrial Estate to a point 119 metres northwest of the centre line of the junction with the U65438 Porthouse Industrial Estate.
- 3. No person shall drive a motor vehicle at a speed exceeding 40 miles per hour along the following length of road:

B4214, Tenbury Road, Bromyard

a) From a point 119 metres northwest of the centre line of the junction with the U65438 Porthouse Industrial Estate for a distance of 470 metres in a generally northerly direction.

and as shown for identification purposes only on the attached plan.

- 4. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
- 5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the following Order will be revoked in its entirety from the date mentioned in Article 1 hereto:



Hereford and Worcester County Council in exercise of their powers under Section 82(2) and 83(2) of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby direct as follows:-

- 1. That length of B4214 Tenbury Road in the Town of Bromyard in the District of Malvern Hills in the County of Hereford and Worcester, which extends from a point 25 metres (82 feet) south of its junction with Winslow Road in a northerly direction to a point 29 metres (95 feet) north of its junction with Porthouse Farm Estate Road, a total distance of 100 metres (328 feet) shall become a restricted road for the purpose of Section 81 of the Road Traffic Regulation Act, 1984;

The Order will come into operation on 11th November 1987.


