# (CHURCH ROAD & ROSS ROAD, BRAMPTON ABBOTTS) (30MPH SPEED LIMIT) ORDER 2019

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under section 84 of the Road Traffic Regulation Act of 1984 (referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. The Order shall come into operation on the 30<sup>54</sup> day of December 2019 and may be cited as "Herefordshire Council (Church Road & Ross Road, Brampton Abbotts) (30mph Speed Limit) Order 2019".
- 2. No person shall drive a motor vehicle at a speed in excess of **30 miles per hour** on the following lengths of road:

C1273 Ross Road - from a point 42 metres north of its junction with U70419 Church Road to a point 472 metres south of its junction with U70419 Church Road

U70419 Church Road - for its entire length

U70420 Church Road - for its entire length

as shown for identification purposes only on the attached plan.

- 3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
- 4. References to any statutory provision herein shall include reference to any statutory modification substitution or re-enactment thereof.
