# HEREFORDSHIRE COUNCIL (B4349 CLEHONGER) (30MPH SPEED LIMIT) ORDER 2019

The County of Herefordshire District Council, known as "Herefordshire Council" in exercise of its powers under section 84 of the Road Traffic Regulation Act of 1984 (referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. This Order shall come into operation on the low day of fully 2020 and may be cited as 'HEREFORDSHIRE COUNCIL (B4349 CLEHONGER) (30MPH SPEED LIMIT) ORDER 2019'.
- 2. No person shall drive a motor vehicle at a speed in excess of **30 miles per hour** along the following lengths of road:

### B4349

From a point 239 metres east of its junction with U73234 to a point 359 metres east of its junction with U73234

and as shown for identification purposes only on the attached plan.

- 3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
- 4. References to any statutory provision herein shall include reference to any statutory modification substitution or re-enactment thereof.
