From its junction with the A449 to a point 380 metres north west of its junction with the C1262.

The Order will come into operation on the 7th September 2012.

- 3 No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 4 Reference to any statutory provisions herein shall include reference to any statutory modification or re-enactment thereof.
