The Parish Council have the following observations on the Regulation 16 submissions:

- The Parish Council welcome the supportive assessment of Herefordshire Council, noting
 particularly the approach taken in relation to planning for future housing. If
 Herefordshire Council can supply an updated housing commitment figure it may help the
 examiner.
- The comments from the Council's Transportation section, whilst accepted in principle, need to be mindful of the area's rural location and limited accessibility by active modes of travel, see also the comments in relation to planning application 163755.
- Welsh Water's comments on the Grampian condition are time limited development management issues and do not need to be addressed in the NDP.
- The comments from landowners make a number of relatively common points, the Parish Council comment as follows:
 - The NDP does not seek to impose an absolute housing figure. The NDP demonstrates how the indicative target supplied by Herefordshire Council can be met over the plan period. With 10 years of the plan period remaining and

the evidence of past windfalls (18) this indicative target will be met and in all likelihood exceeded.

- The housing policies in the NDP and the accompanying settlement boundaries allow for further development, if suitable when assessed in relation to the NDP's policies.

- The allocation of housing sites is not a requirement of neighbourhood plans, it should be considered (paragraph 69 of the Framework). In this case it was, but was rejected by the Parish Council. Paragraph 14 of the Framework is,
 - therefore, irrelevant in the assessment of the NDP.
- The NDP housing policy wording is not imprecise or ambiguous.
- Based on the points in bullet point 4 the Parish Council would not support amendments to the housing polices or settlement boundaries in the NDP, or to go further, the allocation of sites in the NDP.
