

STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)

I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 11 August 2000 the owner of the land known as Drovers Wood, Upper Breinton more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 28 January 2002 the Woodland Trust deposited with Herfordshire Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that:
  - the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways
  - no (other) ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 28 January 2002 referred to in 2 above [other than those bridleways marked in the appropriate colour on the plan accompanying this declaration] and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.

AND I MAKE this solemn declaration on the 28 day of June 2011 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.


The ways coloured green on the said plan have been dedicated as bridleways.

No other ways over the land have been dedicated as highways.

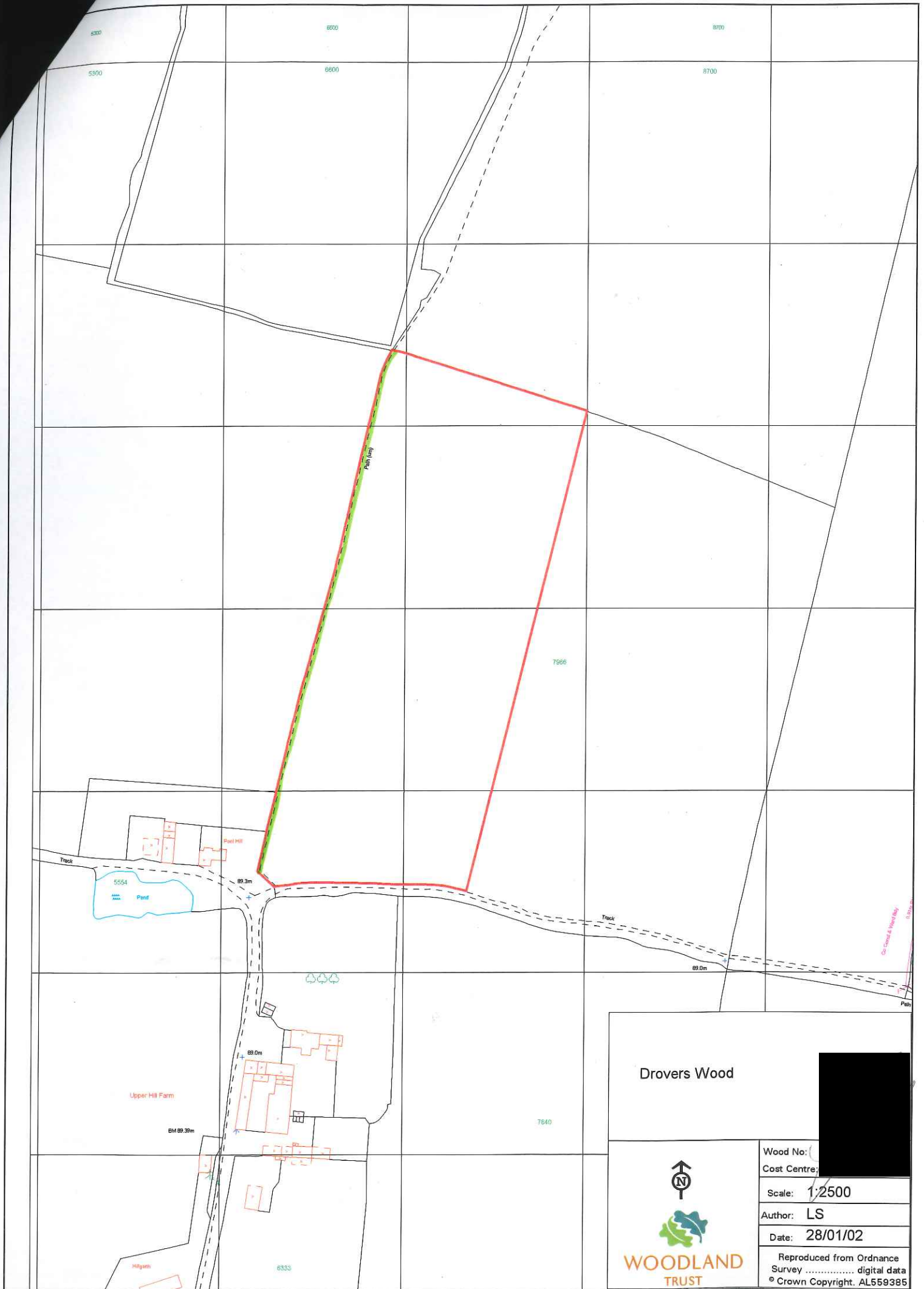
At the present time we have no intention of dedicating any further public rights of way over our property.
