

STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)


I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 29 December 1995 the owner of the land known as Lanes Copse, Burghill more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 9 July 2003 the Woodland Trust deposited with Herefordshire County Council, being the appropriate Council, a statutory declaration stating that no additional way had been dedicated since the deposit of the statement 1 May 1997
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statutory declaration referred to in 2 above and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.



The deposit comprises this statement and the accompanying plan.

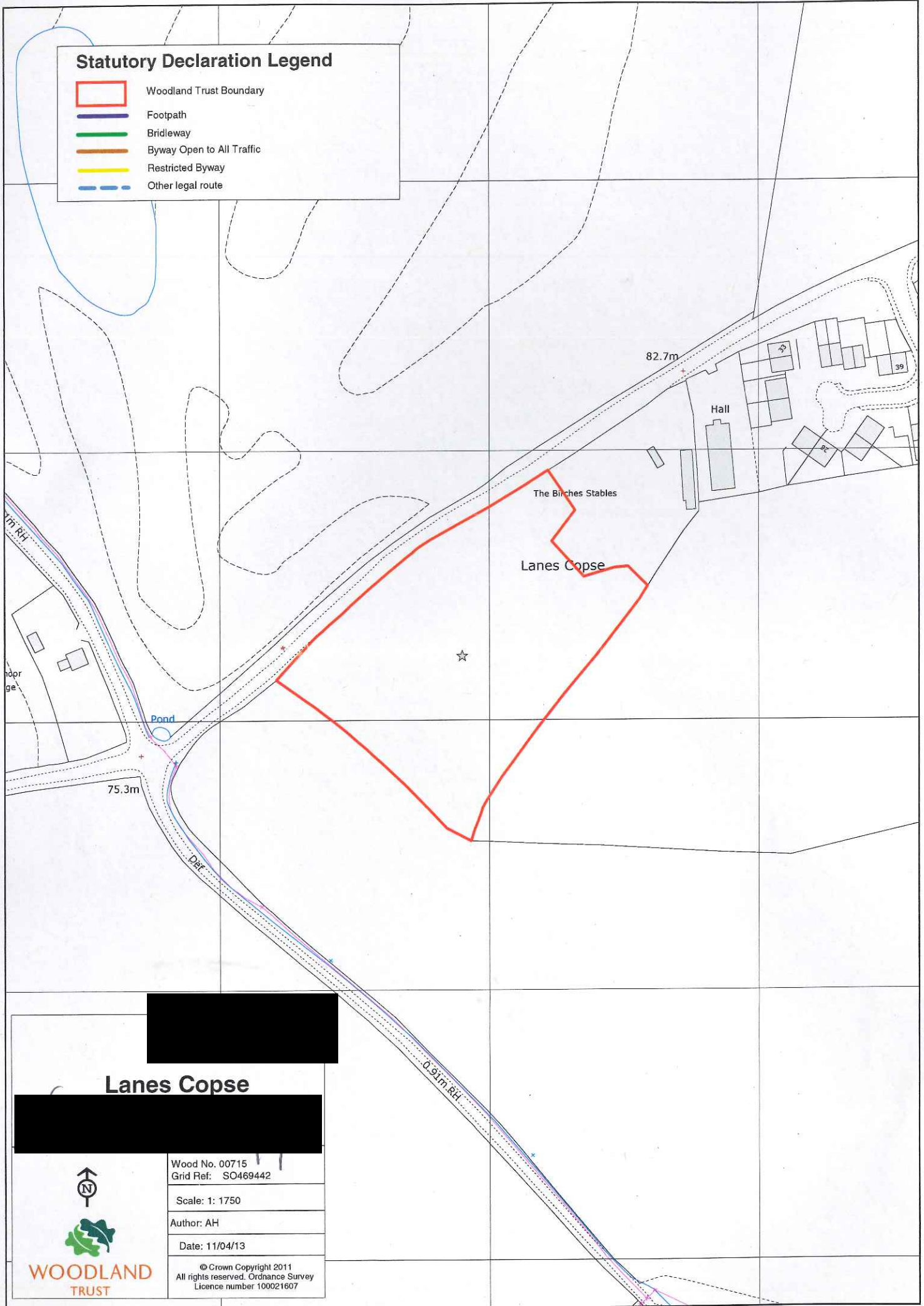
