**STATEMENT PURSUANT TO SECTION 31(6) HIGHWAYS ACT 1980**

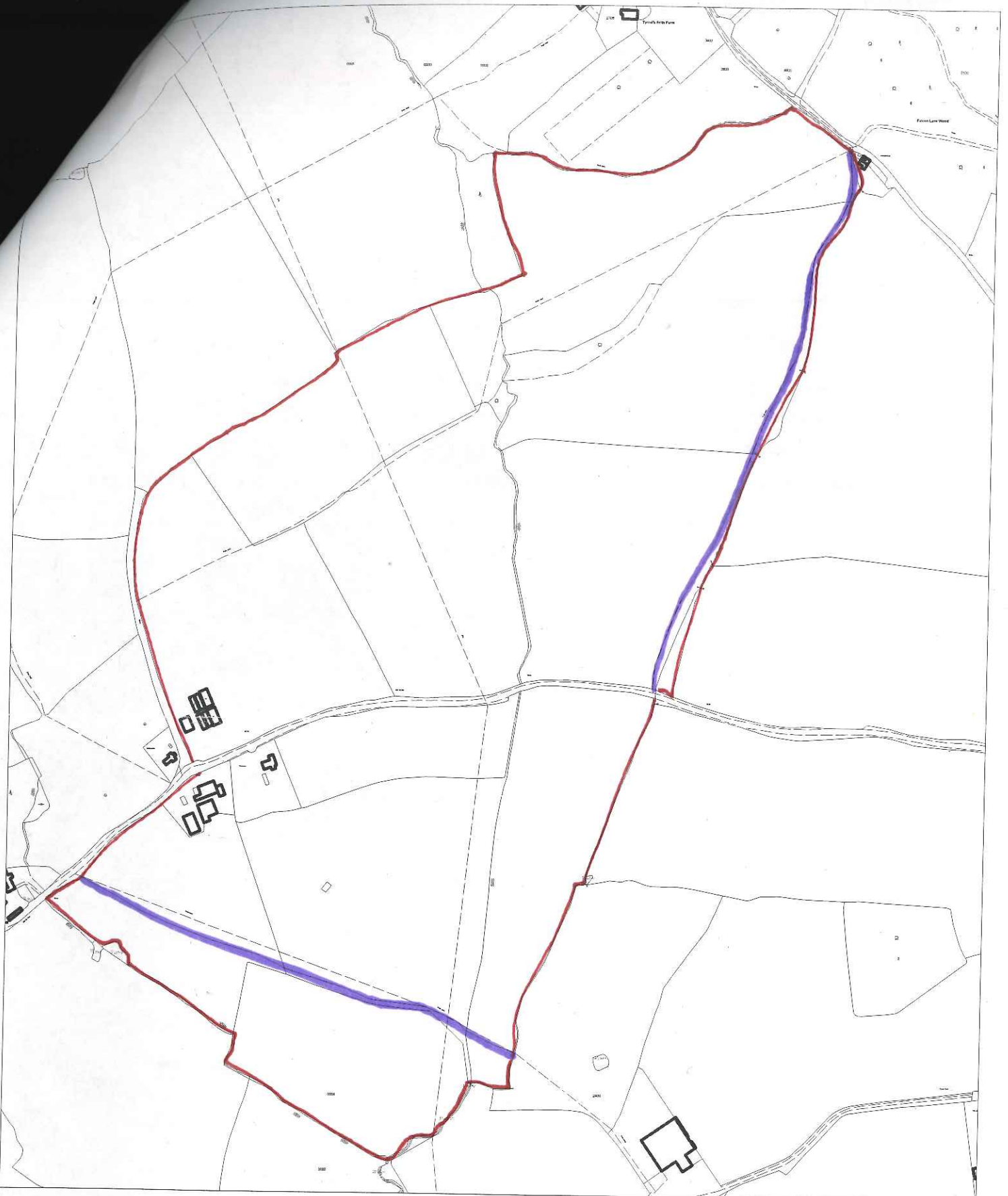

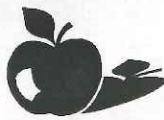
**LOCATION PLAN - Overseas Farm**

STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) GRAHAM FRANCIS BROWNE DO SOLEMNLY AND SINCERELY DECLARE as follows:
