

STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) WILLIAM LLOYD DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since (day, month, year) 4TH JANUARY 2010 the owner of the land known as (name of farm, etc) PINSBY WOOD PASTURE more particularly delineated on the plan accompanying this declaration and thereon edged red.

2. 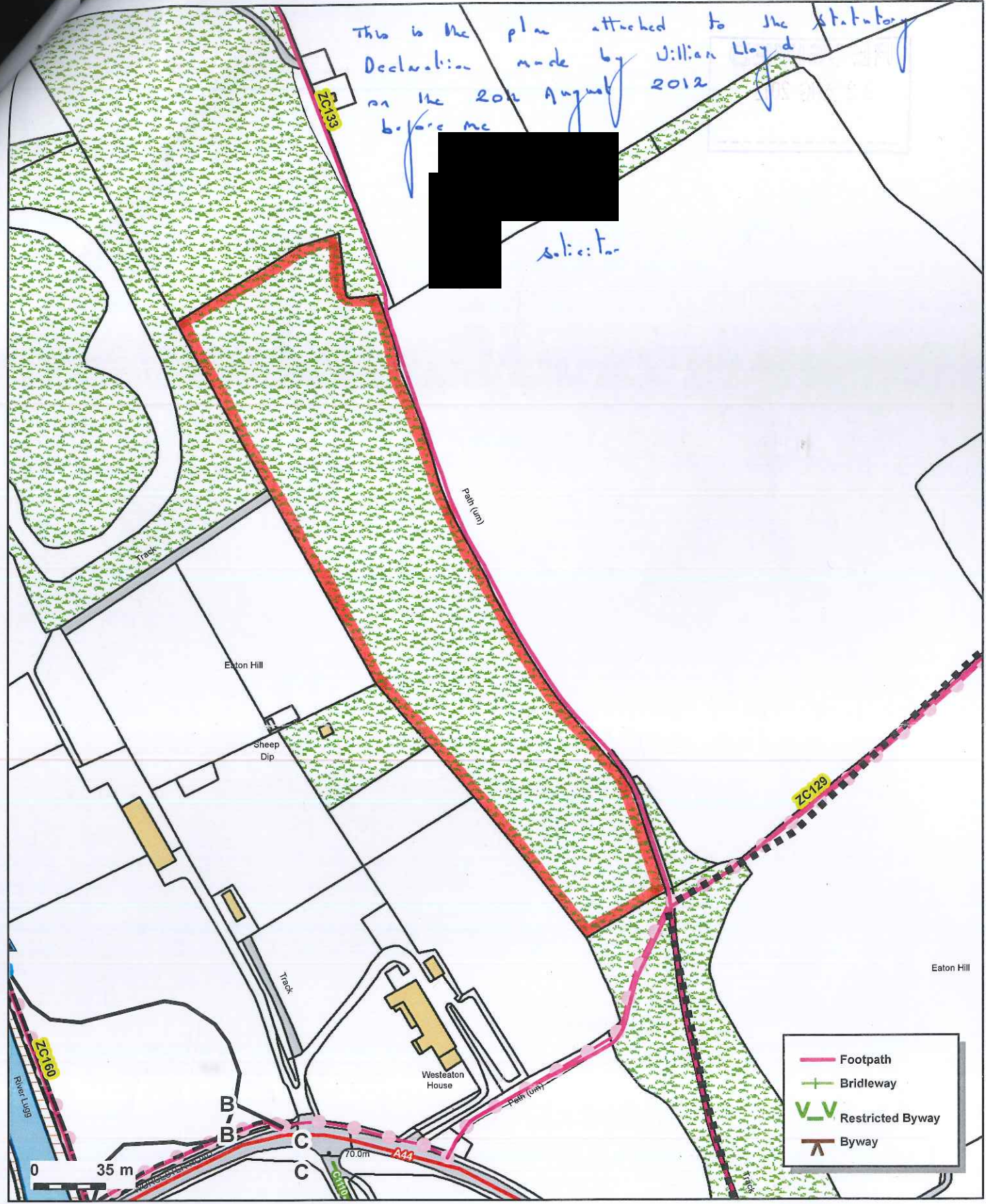
