STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) STELLA SINDEN DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since (day, month, year) 26th July 1990 the owner of the land known as (name of farm, etc) OVERLEY FARMHOUSE more particularly delineated on the plan accompanying this declaration and thereon edged red.

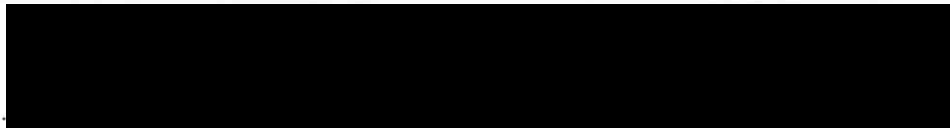

STATEMENT PURSUANT TO SECTION 31(6) HIGHWAYS ACT 1980

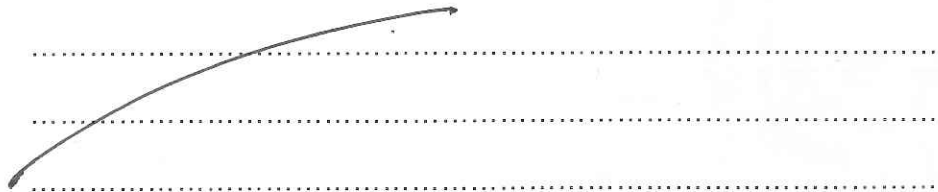

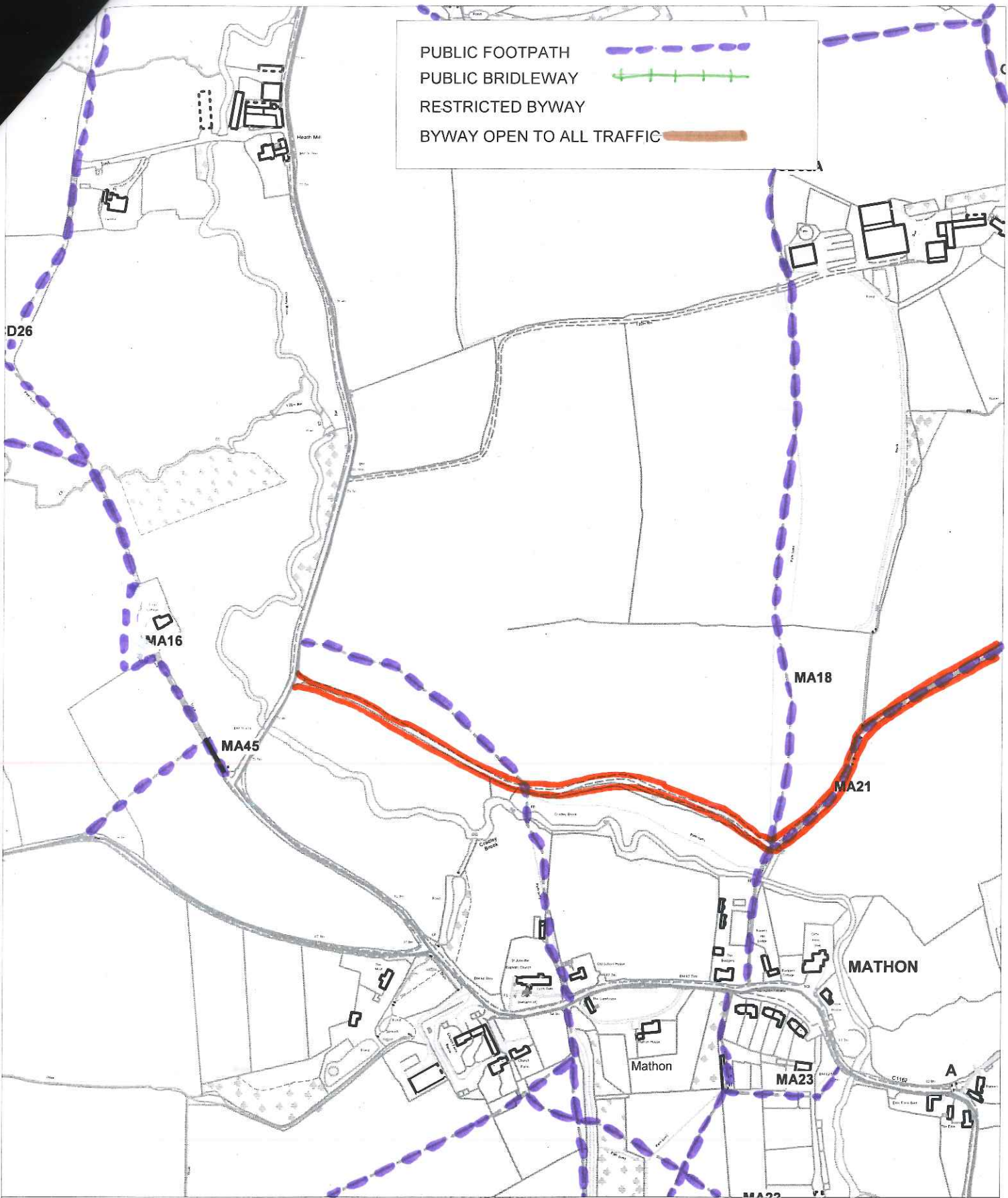
