- B) To introduce permit holders (zone 5)/limited waiting (max stay 1 hour, no return within 2 hours) 9am 8pm restrictions in the following lengths of road:
  - 1) **Foley Street**: *East Side* From the southern boundary of 1 Foley Street to the southern boundary of 77 Foley Street; *West Side* From the southern boundary of 1 Foley Street to the southern boundary of Beverley Court.
- C) To amend the existing permit holders/limited waiting bay in Ledbury Road: North Side - From 80m north-east of the north-eastern kerbline of Central Avenue northeastwards for 27m, to permit holders (zone 5)/limited waiting (max stay 1 hour, no return within 2 hours) 9am – 8pm on all days.
- D) To standardise the terms, conditions and definitions across the residents parking zones in Hereford, where considered appropriate.
