NOTICE OF PROPOSAL (GREYFRIARS)

Herefordshire Council hereby gives notice that in exercise of its statutory enabling powers it is proposing to make **THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (HEREFORD RESIDENTS PARKING) ORDER 2017,** the effect of which will be:

- A) To introduce no waiting at any time restrictions in the following lengths of road:
 - 1) Baysham Street: Both Sides From the eastern kerbline of White Horse Street eastwards for 10m.
 - 2) **Breinton Avenue**: *Both Sides* From the south-western kerbline of Westfaling Street south-westwards for 10m.
 - 3) **Broomy Hill**: *North Side* From 5.5m westwards of the eastern boundary of 64 Broomy Hill westwards to 5.5m east of the western boundary of 76 Broomy Hill and From 10m east of the eastern kerbline of Prince Edward Road eastwards for 90m; *South Side* From 15m west of the extended western boundary of Camperdown Lane to 1m west of the western boundary of 71 Broomy Hill and From 31m west of the western boundary of 71 Broomy Hill to 5m west of the extended boundary line of 76 Broomy Hill.
 - 4) Chandos Street: Both Sides From the eastern kerbline of White Horse Street eastwards for 10m; South Side - From 10m west of the western kerbline of Stanhope Street to 10m east of the eastern kerbline of Stanhope Street.
 - 5) **Clifford Street**: *Both Sides* From its junction with Scudamore Street northwards to 10m north of the northern kerbline of Scudamore Street and From the southern kerbline of Cotterell Street southwards for 10m; *East Side* From 10m north of the northern kerbline of Cornewall Street to 10m south of the southern kerbline of Cornewall Street.
 - 6) **Cornewall Street**: *Both Sides* From the eastern kerbline of Clifford Street eastwards for 10m and From the western kerbline of White Horse Street westwards for 10m.
 - 7) Cotterell Street: South Side From 10m west of the western kerbline of Clifford Street to 10m east of the eastern kerbline of Clifford Street, From 10m west of the western kerbline of Windsor Street to 10m east of the eastern kerbline of Windsor Street and From the western kerbline of White Horse Street westwards for 9m.
 - 8) **Holmer Street**: *East Side* From 10m north of the northern kerbline of Scudamore Street southwards to 10m south of the southern kerbline of Scudamore Street and From 10m north of the northern kerbline of Thompson Place southwards to 10m south of the southern kerbline of Thompson Place.
 - 9) Prince Edward Road: East Side From 10m north of the northern kerbline of Broomy Hill northwards for 10m, From 54.5m north of the northern kerbline of Broomy Hill northwards 5m, From 73.5m north of the northern kerbline of Broomy Hill northwards 5m and From 84.5m north of the northern kerbline of Broomy Hill northwards 8m; West Side From 10m north of the northern kerbline of Broomy Hill to 10m south of the southern kerbline of Tower Road.
 - Scudamore Street: Both Sides From the eastern kerbline of Holmer Street eastwards for 10m; North Side From 10m west of the western kerbline of Windsor Street eastwards to 10m east of the eastern kerbline of Windsor Street and From its junction with Clifford Street westwards to the extended western boundary of 3 Scudamore Street; South Side From 4m south-east of the extended eastern kerbline of Windsor Street north-westwards 18m and From its junction with Clifford Street westwards to the eastern boundary of 3 Scudamore Street.
 - 11) **Stanhope Street**: *Both Sides* From the southern kerbline of Chandos Street southwards for 10m and From the north-eastern kerbline of Westfaling Street north-eastwards for 10m.
 - 12) **Thompson Place**: *Both Sides* From the south-eastern kerbline of Holmer Street south-eastwards for 10m.
 - 13) **Tower Road**: *North & West Sides* From 52m east of the eastern kerbline Prince Edward Road to 12m south of the southern kerbline of Breinton Road; *South & East Sides* From 61m east of the eastern kerbline of Prince Edward Road to the south-western boundary of 1 Tower Road and From 12m south of the southern kerbline of Breinton Road southwards for 9m.
 - 14) **Westfaling Street**: *South Side* From 16.5m northwest of the north-western kerbline Breinton Avenue to 15m southeast of the south-eastern kerbline of Breinton Avenue.
 - 15) Whitecross Road: North Side From 10m north of the western kerbline of Mostyn Street to 10m south of the eastern kerbline of Mostyn Street.
 - 16) White Horse Square: Both Sides From the western kerbline of White Horse Street westwards for 10m.
 - 17) White Horse Street: East Side From 10m north of the northern kerbline of Baysham Street to 10m south of the southern kerbline of Baysham Street and From 10m north of the northern kerbline of Chandos Street to 10m south of the southern kerbline of Chandos Street; West Side From the southern kerbline of Cotterrell Street southwards for 10m, From 10m north of the northern kerbline of Cornewall

- Street to 10m south of the southern kerbline of Cornewall Street and From 10m north of the northern kerbline of White Horse Square to the southern boundary of 3 White Horse Court.
- 18) **Windsor Street**: *Both Sides* From the southern kerbline of Cotterell Street southwards for 10m and From the northern kerbline of Scudamore Street northwards for 10m.
- B) To introduce no waiting 8am 4pm Monday to Friday restrictions in the following lengths of road:
 - Broomy Hill: North Side From 10m west of the western kerbline of Prince Edward Road to 5.5m west of the eastern boundary of 64 Broomy Hill; South Side - From 1m west of the western boundary of 71 Broomy Hill westwards for 30m.
- C) To introduce permit holders (zone B)/limited waiting (max stay 1 hour, no return within 2 hours) 9am 8pm restrictions in the following lengths of road:
 - 1) **Baysham Street**: *Both Sides* From 18m west of the western kerbline of Ryelands Street westwards to 10m east of the eastern kerbline of White Horse Street.
 - 2) **Bedford Street**: *Both Sides* From 13m east of the eastern kerbline of Guildford Street to 13m west of the western kerbline of Oxford Street.
 - 3) **Guildford Street**: *East Side* From 16m south of the southern kerbline of Whitecross Road to 13m north of the northern kerbline of Bedford Street and From 4m south of the southern kerbline of Bedford Street southwards to its closed end; *West Side* From 16m south of the southern kerbline of Whitecross Road southwards to its closed end; *Closed End* For its entire length.
 - 4) Oxford Street: East Side From 16m south of the southern kerbline of Whitecross Road to 14m north of the extended northern kerbline of Bedford Street and From 5.5m south of the extended southern kerbline of Bedford Street southwards for 15m; West Side From 16m south of the southern kerbline of Whitecross Road to 11m north of the northern kerbline of Bedford Street and From 5m south of the southern kerbline of Bedford Street southwards 15m.
- D) To amend the following existing permit holders/limited waiting bays to permit holders (zone 12)/limited waiting (max stay 1 hour, no return within 1 hour) 8am 8pm on all days:
 - Old Mill Close: North Side From 14m west of the western kerb line of Friars Street westwards for 15m, From 37m west of the western kerb line of Friars Street westwards for 28m and From 74 m west of the western kerb line of Friars Street westwards for 15m.
- E) To amend the following existing permit holders/limited waiting bays to permit holders (zone B)/limited waiting (max stay 2 hours, no return within 2 hours) 9am 8pm on all days:
 - 1) **Ryelands Street**: *East Side* From 106m southwest of the southern kerbline of Whitecross Road southwards 52.5m, From 22.5m south-west of the southern kerbline of Whitecross Road southwards 6.5m, From 81.5m south-west of the southern kerbline of Whitecross Road southwards 6.5m and From 91.5m south-west of the southern kerbline of Whitecross Road southwards 10.5m.
- F) To standardise the terms, conditions and definitions across the residents parking zones in Hereford, where considered appropriate.
