

NOTICE OF PROPOSAL (CENTRAL)

Herefordshire Council hereby gives notice that in exercise of its statutory enabling powers it is proposing to make **THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (HEREFORD RESIDENTS PARKING) ORDER 2017**, the effect of which will be:

- A) To introduce no waiting at any time restrictions in the following lengths of road:
- 1) **Castle Street: North Side** - From 3m west of the western kerbline of Ferrers Street to 3.5m east of the eastern kerbline of Ferrers Street and From the western kerbline of St Ethelbert Street westwards for 4m; **South Side** - From 3.5m west of the western kerbline of Quay Street to 2.5m east of the eastern boundary of Quay Street.
 - 2) **Delinquent Passage: All Sides** - For its entire length.
 - 3) **East Street: Both Sides** - From the south-eastern boundary of 20 East Street to the north-western boundary of 24 East Street.
 - 4) **Ferrers Street: Both Sides** - For its entire length.
 - 5) **Gaol Street: Both Sides** - From the north-eastern kerbline of St Owen Street to 32m north-west of the northern kerbline of Delinquents Passage.
 - 6) **Gwynne Street: North-West Side** - From the south-western boundary of 5 Palace Yard south-westwards for 69.5m; **South-East Side** - From the south-western boundary of 5 Palace Yard south-westwards for 85m.
 - 7) **Quay Street: Both Sides** - From the southern kerbline of Castle Street southwards for 56.5m.
 - 8) **St. Ethelbert Street: West Side** - From the northern kerbline of Castle Street northwards for 11.5m.
- B) To introduce permit holders (zone 3)/limited waiting (max stay 1 hour, no return within 2 hours) 9am – 6pm Monday to Saturday restrictions in the following lengths of road:
- 1) **Harold Street: South Side** - From 7m east of the eastern kerbline of Hampton Street eastwards for 9m.
 - 2) **Mill Street: East Side** - From 10m north of the northern kerbline of Nelson Street northwards for 9m; **West Side** - From 116.5m east of the western closed end of Mill Street northwards for 39.5m and From 9.5m east of the western closed end of Mill Street northwards for 88m.
- C) To introduce a no stopping except buses 8am – 4.30pm Monday to Friday restriction in **Mill Street: West Side** - From 97.5m north of the western closed end of Mill Street northwards for 19m.
- D) To standardise the terms, conditions and definitions across the residents parking zones in Hereford, where considered appropriate.
