HIGHWAYS ACT 1980

THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (A465 (HEREFORD LINK ROAD) CLASSIFIED ROAD) (SIDE ROADS AND OTHER WORKS)
ORDER 2013

THE SECRETARY OF STATE for Transport hereby gives notice that he has confirmed, with modifications, the above Order which was made by The County of Herefordshire District Council under sections 6, 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the Council to –

- a) improve highways;
- b) stop up highways;
- c) construct new highways;
- d) stop up private means of access to premises; and
- e) provide new means of access to premises,

all on or in the vicinity of the route of the classified road which the Council propose to construct from a point on Edgar Street, Hereford (A49 Trunk Road) 21 metres south of Prior Street for a distance of 808 metres eastwards to its junction with Commercial Road, Hereford.

Copies of the above mentioned Order and of the plans referred to therein may be inspected free of charge at all reasonable hours at the offices of the Council at the Hereford Customer Service Centre, Franklin House, 4 Commercial Road, Hereford HR1 2BB.

ANY PERSON aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 9 October 2014, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
