	Professor Mary Stuart, Vice Chancellor, University of Lincoln opened the day with a presentation emphasising the importance of the university to the city, and stressing the value of embedding it within the city. This was followed by presentations from the City of Lincoln and Lincolnshire County Council. Following lunch they were taken on tours of the Isaac Newton Building, the University's School of Engineering and the Student Accommodation.		
	Lincoln has a partnership with Siemens. Our feeling is that it is better to work with several smaller businesses rather than rely on a single large employer. The University will produce students with engineering skills who are work ready and this could be used to encourage growth within the county by attracting big businesses who find it difficult to recruit engineers with the skills they require.		
	Lincoln University have great student accommodation close to the campus, however there have been issues with privately rented student accommodation with complaints received from neighbours.		
4.	FEEDBACK FROM HISTORIC ENGLAND WORKSHOP ON 04 & 05 OCTOBER The team were enormously encouraged to hear the panel's thoughts and that they are supportive of the council's ambitions. It was felt that this will enable the creation of an imaginative plan for the city.

	HE identified a number of sites for development where it would previously have been seen as unlikely to receive support, and some that we had not considered.	
	The biggest challenge going forward is getting property settled so that conversations can move forward and be linked with the master planning for the city. They were clear that we must develop a master plan for the city to ensure areas such as Commercial Road / Street and the main exit from the train station are improved as they feel this route is critical for improvement.	
	The need to engage with the community to look at solutions for how to turn Hereford into a University City was highlighted.	
	Historic England is writing a report which will contain recommendations. This will help us to lobby others for funds or resources and to inform our work plan going forward.	
5.	UNIVERSITY DEVELOPMENT UPDATE – Janusz Kozinski Several priorities have been identified including the formal agreement with partners in Warwick.	
	Discussions about branding and marketing are advancing and they hope to have this in place soon.	
	NMiTE are in the final stages of identifying five senior leadership positions at the University, including Chief Fundraising Officer, Chief Operating Officer and Chief Brand and Marketing Officer. It is hoped they will all be in post by January 2018.	
	Discussions took place about the need to ensure that cycling and cycle routes are incorporated into plans to prevent additional traffic on already congested roads.	
6.	PROPERTY UPDATE – David Sheppard / Doug Reid Dr advised that discussions have been held with relevant officers about the availability of Council owned properties within Hereford City. A property group is being formed to push forward discussions.	
	Discussions took place about potential locations for University buildings.	
7.	PROJECTS – Richard Gabb RG has forwarded AP a list of nominees from HC for each of the projects.	
8.	FUNDING UPDATE - David Sheppard <u>DfE Funding</u> DS due to meet with officials from the finance division of the DfE on 11 October to talk about the phasing of the payments over the five years. The university team will be required to achieve various fundraising targets over the period.

	DN advised that the majority of the funding is revenue, which is a major shift from original discussions where DfE said they only fund capital.
