U70206 Whitehall Road from its junction with the A40 Weston Under Penyard north-eastwards for a distance of 410 metres, U70208 School Lane for its entire length, U70208 Hyde Orchard for its entire length, U70209 Penyard Gardens for its entire length, U70763 Hunsdon Manor Gardens for its entire length, U70766 Weston Park for its entire length and that no person shall drive a motor vehicle at a speed exceeding 40 miles per hour along the following length of road: A40 Weston Under Penyard from a point 192 metres northwest of its junction with the U70205 Church Road north-westwards for a distance of 437 metres. The above order re-establishes the existing 30 mph and 40 mph speed limits and extends the existing 30 mph speed limit on the A40 from its current termination point adjacent to Penyard Gardens to a point 30 metres east of the Bury Hill Lane junction. The Order shall come into operation on 27 July 2018. 




