The inclusion of map 6 (presently being clarified) showing LANP11 protected green spaces has enabled these to be compared with the Ordnance Survey Getoutside Greenspaces map, see https://getoutside.ordnancesurvey.co.uk/greenspaces/ of open green spaces, with Leominster Town Council resolving to request Ordnance Survey to include the open green spaces identified in LANP11, expected to include those marked in blue below:

Local MP, Bill Wiggin, asked to check that Ordnance Survey would be receptive to this type of feedback has written to the Minister, with reply awaited.


This could expected to satisfy the Habitat Regulation Assessment, but the lack of any equivalent map of our instrastructure in LANP26 brings this into question?



Further to my representation of 12 October, I have been advised by the Minister that OS are always very happy to include greenspaces in the Getoutside Greenspaces map that are not currently shown, but could not include the 8 greenspaces in blue below due to lack of information re whether they are areas of land accessible to the public or private land, nor private land crossed by a public path.

Clearly the Neighbourhood Development Plan Greenspace Map 6 subject of consultation could provide OS with the information they require, defining which areas are open access greenspace, with our authority requesting OS to include these in conformance with provision LANP11?
