Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under section 84 of the Road Traffic Regulation Act 1984, has made the above named order the effect of which will be to reduce the existing national speed limit to 40 mph on the A4110 to the north and south ends of Wigmore in advance of the existing 30 mph speed limit from a point 160 metres northwest of its junction with Ford Street for a distance of 363 metres in a generally northerly direction and from a point 20 metres southeast of its junction with the C1009 for a distance of 600 metres in a generally southern direction

This Order will come into operation on 23 November 2018.

ROAD TRAFFIC REGULATION ACT 1984

HEREFORDSHIRE COUNCIL (A4110, WIGMORE) (40 MPH SPEED LIMIT) ORDER 2018

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under section 84 of the Road Traffic Regulation Act 1984 (referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. The Order shall come into operation on 23 Nov 2018 and may be cited as "Herefordshire Council (A4110, Wigmore) (40 mph speed limit) Order 2018".
- 2. No person shall drive a motor vehicle at a speed exceeding 40 miles per hour along the following lengths of road:

A4110, Wigmore

- a) From a point 160 metres northwest of its junction with the C1019 Ford Street for a distance of 363 metres in a general northerly direction;
- b) From a point 20 metres southeast of its junction with the C1009 for a distance of 600 metres in a general southerly direction.


- 3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
- 4. References to any statutory provision herein shall include reference to any statutory modification substitution or re-enactment thereof.


