### **Section 1: Monitoring the Local Development Scheme**

#### Introduction

- 1.1 This section reports on progress in achieving the timetable and milestones set out in the Council's Local Development Scheme (LDS) January 2015 which was still in place at April 2018.
- 1.2 Each proposed Local Development Document identified in the LDS is listed below, with a brief review of progress. The LDS was updated in August 2018 to reflect the latest timetable for the preparation of the remaining elements of the Local Plan and this document will form the basis for monitoring Development Plan progress in 2019.

#### Summary of Progress up to April 2018.

#### Local Plan - Core Strategy

- 1.3 Work on the Core Strategy began in September 2006. Various consultation stages were undertaken between June 2007 and March 2013. The pre-submission publication period took place between May and July 2014. The Plan was submitted to the Secretary of State in September 2014. Hearings took place early in 2015 with adoption in October 2015.
- 1.4 The LDS 2015 anticipated that the Core Strategy would be adopted in the summer of 2015.

#### Hereford Area Plan

1.5 The LDS anticipated a summer 2015 for an Issues and Options consultation. However, there have been delays to this process which means that consultation upon the plan was undertaken in spring 2017. As there will be subsequent delays to other stages if plan preparation these will be reflected in a revised LDS.

#### **Minerals and Waste Local Plan**

1.6 The 2015 LDS suggested public consultation a Natural Resources DPD issues and options consultation in Summer 2015. However, the Core Strategy Inspector recommended the preparation of a Minerals and Waste Local Plan rather than the Natural Resources document. Progress on the document did not get underway until 2016. Issues and Options Consultation was undertaken in Summer/Autumn 2017. Timetable is set out in the revised LDS which will be used to monitor the position in future years.

1.7 The latest LDS also makes reference to the preparation of a Rural Areas Sites Allocation Development Plan Document and Bromyard Development Plan. Progress on these documents will be reported in future monitoring reports.

#### **Supplementary Planning Documents**

1.8 The 2015 LDS includes reference to two proposed SPDs regarding Planning Obligations and a Design Guide Portfolio. These documents were to be progressed following the adoption of the DPDs but as the timetables for those documents have not been achieved as anticipated the work on the SPDs has not been undertaken.
