HEREFORDSHIRE COUNCIL (B4219 COWLEIGH ROAD, STORRIDGE) (40 MPH AND 50 MPH SPEED LIMITS) ORDER 2018

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under section 84 of the Road Traffic Regulation Act of 1984 (referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. The Order shall come into operation on 30° November 2018 and may be cited as "Herefordshire Council (B4219 Cowleigh Road, Storridge) (40 mph and 50 mph speed limits) Order 2018".
- 2. No person shall drive a motor vehicle at a speed exceeding 40 miles per hour along the following length of road:

B4219 Cowleigh Road, Storridge

From a point 18 metres south east of its junction with the A4103 to a point 20 metres south east of its junction with the U65630 Crumpton Hill Road.

3. No persons shall drive a motor vehicle at a speed exceeding 50 miles per hour along the following length of road:

B4219 Cowleigh Road, Storridge

From its junction with the A4103 for a distance of 18 metres in a south easterly direction.

- 4. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
- 5. References to any statutory provision herein shall include reference to any statutory modification substitution or re-enactment thereof.
