THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (HEREFORD CITY CENTRE) ORDER 2019

The Council in exercise of its powers under Sections 1, 2, 4, 32(1), 35(1), 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act"), Section 63 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

PART ONE – INTRODUCTION

CITATION

1.1 This order shall come into operation on the [Date] and may be cited as The County of Herefordshire District Council (Hereford City Centre) Order 2019.

INTERPRETATION

- **1.2** In this Order, except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that article or schedule in this Order.
- **1.3** In this Order any reference to an Act, Statutory Instrument, Regulation or Order shall be construed as a reference to that Act, Statutory Instrument or Order as amended.
- **1.4** In this Order the following expressions shall have the respective meanings assigned to them:

"Bus" means a Motor Vehicle constructed or adapted to carry more than 8 seated passengers in addition to the driver.

"Business Parking Permit" means a Parking Permit which can only be issued to an eligible business in accordance with the provisions of this Order

"Civil Enforcement Officer" means a person appointed in accordance with the provisions of Section 76 Traffic Management Act 2004.

"Council" means The County of Herefordshire District Council (known as Herefordshire Council).

"Disabled Persons Vehicle" means a vehicle displaying a valid disabled persons badge in accordance with The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

"Driver" means the person engaged in the driving of the vehicle.

"Dwelling", means a house or self-contained flat registered for Council Tax purposes.

"Goods Vehicle" means a motor vehicle constructed or adapted for use for the carriage of goods, or a trailer so constructed or adapted and which said motor vehicle is physically constructed or adapted so as to prohibit the carrying of passengers (other than front seat passengers) but (for the avoidance of doubt) does not include estate motor vehicles or hatchback vehicles which may be so adapted.

"Invalid Carriage" has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984.

"Light Goods Vehicle" means a Motor Vehicle, the maximum gross weight of which does not exceed 3.5 tonnes, which is constructed or adapted for use for the carriage of goods or burden of any description, and is not drawing a trailer.

"Motor Cycle/s" has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984.

"Motor Vehicle" has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984.

"Owner", in relation to a vehicle, means the person by whom such vehicle is kept and used and in determining who the owner of a vehicle was at any time it shall be presumed that the owner was the person in whose name the vehicle was at that time registered under the Vehicle Excise and Registration Act 1994.

"Parking Meter" means apparatus designed to indicate the time and issue a ticket indicating the payment of a charge and the period in respect of which it has been paid and/or the time at which the period paid for will expire.

"Parking Permit Holder", means a person to whom a Parking Permit has been issued.

"Parking Permit", means a document issued by the Council under the provisions of this Order which exempts a vehicle from certain parking restrictions.

"Parking Place" means any lengths of a road so marked (if any) and authorised by this Order to be used for parking.

"Passenger Vehicle/s" means a Motor Vehicle (other than a Motor Cycle or Invalid Carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the Driver, and not drawing a trailer.

"Public Service Vehicle" means a motor vehicle, including a tramcar or trolley vehicle, used for carrying passengers for hire or reward which either (1) is carrying passengers at separate fares: or (2) is not carrying passengers for separate fares but is adapted to carry eight or more passengers.

"Residents Parking Permit" means a Parking Permit which can only be issued to an eligible resident in accordance with the provisions of this Order for use in respect of a vehicle owned by the resident.

"Taxi" means a Hackney Carriage as defined in Section 38 of the Town Police Clauses Act 1847 and licenced under Section 37 of that Act.

"Ticket" means a ticket issued by a Parking Meter which indicates the payment of a charge and the period in respect of which it has been paid and/or the time at which the period paid for will expire.

"Visitors Parking Permit" means a Parking Permit which can only be issued to an eligible resident in accordance with the provisions of this Order for use in respect of vehicles being used by persons visiting the residence.

"Zone A" means East Street, Hereford or such other lengths of road as the Council shall decide.

"Zone 2" means Castle Street, Cantilupe Street and St Ethelbert Street, Hereford or such other lengths of road as the Council shall decide.

PART TWO - PROHIBITION OF WAITING AND LOADING

NO WAITING AT ANY TIME

2.1 No person shall cause or permit any vehicle to wait in the lengths of road specified in Schedule 1.

NO WAITING DURING RESTRICTED HOURS

2.2 No person shall cause or permit any vehicle to wait in the lengths of road specified in columns 1, 2 and 3 of Schedule 2 during the hours specified in column 4 of Schedule 2.

NO WAITING EXCEPT TAXIS

2.3 No person shall cause or permit any vehicle other than a Taxi to wait in the lengths of road specified in columns 1, 2 and 3 of Schedule 3 during the hours specified in column 4 of Schedule 3.

NO LOADING AT ANY TIME

2.4 No person shall cause or permit any vehicle to wait in the lengths of road specified in Schedule 4.

NO LOADING DURING RESTRICTED HOURS

2.5 No person shall cause or permit any vehicle to wait in the lengths of road specified in columns 1, 2 and 3 of Schedule 5 during the hours specified in column 4 of Schedule 5.

PART THREE – PARKING PLACES

DESIGNATION OF PARKING PLACES

3.1 The lengths of road specified in columns 1, 2 and 3 of Schedules 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 and 18 having a width as indicated by road markings complying with Department for Transport regulations or other approved designs, with the exception of vehicular access footway crossovers to adjoining properties and other authorised access points from the carriageway, are designated as Parking Places.

USE OF PARKING PLACES

- **3.2** A vehicle left in a Parking Place must be parked wholly within the boundary of that parking place.
- **3.3** No vehicle left in a Parking Place shall be in a position which prevents access to any premises or which obstructs other road users.
- **3.4** The driver of a Motor Vehicle using a Parking Place must stop the engine as soon as the vehicle is in position and must not start the engine except to change the position of the vehicle or depart from the Parking Place.
- **3.5** Unless the prior written consent of the Council is obtained no vehicle left in a Parking Place shall be used in connection with the sale of any goods or services except where goods (including postal parcels) are being delivered to any premises in the immediate area.

SUSPENSION OF PARKING PLACES

- **3.6** The Council or any person so authorised by the Council may suspend the use of any Parking Place or part of a Parking Place without prior notice. No person shall cause or permit any vehicle to wait in a Parking Place which has been suspended.
- **3.7** The Council or any person so authorised by the Council may suspend the restrictions, including the charges, which apply to any Parking Place or part of a Parking Place without prior notice.

REMOVAL OF VEHICLES

- **3.8** Where a vehicle is in contravention of Article 3.3 or Article 3.6 the Council or any person so authorised by the Council or a police officer or Civil Enforcement Officer in uniform may remove the vehicle or arrange for the vehicle to be removed from the Parking Place in any manner as they consider necessary.
- **3.9** Any person removing or arranging for a vehicle to be removed under Article 3.8 must make such arrangement as reasonably necessary for the reasonable safe custody of that vehicle.

LIMITED WAITING FOR BUSES

- **3.10** No person shall cause or permit any vehicle other than a Bus to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 6 during the hours specified in column 4 of Schedule 6.
- **3.11** No person shall cause or permit a Bus to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 6 during the hours specified in column 4 of Schedule 6 for longer than the period of time specified in column 5 of Schedule 6.
- **3.12** No person shall cause or permit a Bus waiting in the Parking Places specified in columns 1, 2 and 3 of Schedule 6 during the hours specified in column 4 of Schedule 6 to return to the same Parking Place within the period of time specified in column 6 of Schedule 6.

PERMIT PARKING

3.13 No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 7 during the hours specified in column 4 of Schedule 7 unless that vehicle is displaying a valid Parking Permit for the Zone specified in column 5 of Schedule 7.

PERMIT PARKING OR LIMITED WAITING

- **3.14** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 8 during the hours specified in column 4 of Schedule 8 for longer than the period of time specified in column 5 of Schedule 8 unless that vehicle is displaying a valid Parking Permit for the Zone specified in column 7 of Schedule 8.
- **3.15** No person shall cause or permit any vehicle waiting in the Parking Places specified in columns 1, 2 and 3 of Schedule 8 during the hours specified in column 4 of Schedule 8 to return to the same Parking Place within the period of time specified in column 6 of Schedule 8 unless that vehicle is displaying a valid Parking Permit for the Zone specified in column 7 of Schedule 8.

DISABLED BADGE HOLDER PARKING

- **3.16** No person shall cause or permit any vehicle other than a Disabled Persons Vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 9 during the hours specified in column 4 of Schedule 9.
- **3.17** No person shall cause or permit a Disabled Persons Vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 9 during the hours specified in column 4 of Schedule 9 for longer than the period of time specified in column 5 of Schedule 9.
- **3.18** No person shall cause or permit a Disabled Persons Vehicle waiting in the Parking Places specified in columns 1, 2 and 3 of Schedule 9 during the hours specified in column 4 of Schedule 9 to return to the same Parking Place within the period of time specified in column 6 of Schedule 9.

PAY AND DISPLAY PARKING

- **3.19** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 10 during the hours specified in column 4 of Schedule 10 unless the appropriate charge for the length of stay, as specified in Schedule A, has been paid.
- **3.20** The charge described in Article 3.19 shall be payable by:
 - (a) the insertion into a Parking Meter which relates to the Parking Place of coins (or notes where such a facility is available); or
 - (b) credit or debit card at a Parking Meter which relates to the Parking Place (where such a facility is available); or

- (c) use of a pay by phone, pay by text or pay by app system (where such a facility is available).
- **3.21** Where a Ticket has been issued from a Parking Meter it must be displayed; in the case of a vehicle fitted with a transparent windscreen, so that it is facing upwards and can be entirely and easily seen from outside the vehicle; or in the case of a vehicle which is not fitted with a transparent windscreen, in a conspicuous position on the vehicle. Multiple Tickets' shall not be displayed.
- **3.22** The time at which the length of stay paid for will expire shall be as specified:
 - (a) on the Ticket issued by the Parking Meter; or
 - (b) on a hand-held device which indicates when a charge has been paid by phone, text or app.
- 3.23 A Ticket shall cease to be valid at the time specified on it.
- **3.24** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 10 during the hours specified in column 4 of Schedule 10 after the expiry of the length of stay paid for.
- **3.25** The length of stay paid for shall not be extended beyond the initial period (i.e. no meter feeding), for the avoidance of doubt this provision applies even if such an extension would not cause the vehicle to wait for a period of time longer than the maximum stay period specified in column 5 of schedule 10.
- **3.26** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 10 during the hours specified in column 4 of Schedule 10 for longer than the period of time specified in column 5 of Schedule 10.
- **3.27** No person shall cause or permit any vehicle waiting in the Parking Places specified in columns 1, 2 and 3 of Schedule 10 during the hours specified in column 4 of Schedule 10 to return to the same Parking Place within the period of time specified in column 6 of Schedule 10.

LOADING BAY

- **3.28** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 11 during the hours specified in column 4 of Schedule 11, unless that vehicle is waiting for the purpose of loading or unloading goods from that vehicle.
- **3.29** No person shall cause or permit any vehicle waiting for the purpose of loading or unloading goods from that vehicle in the Parking Places specified in columns 1, 2 and 3 of Schedule 11 during the hours specified in column 4 of Schedule 11 to wait for longer than the period of time specified in column 5 of Schedule 11.
- **3.30** No person shall cause or permit any vehicle waiting for the purpose of loading or unloading goods from that vehicle in the Parking Places specified in columns 1, 2 and 3 of Schedule 11 during the hours specified in column 4 of Schedule 11 to return to the same Parking Place within the period of time specified in column 6 of Schedule 11.

GOODS VEHICLE LOADING BAY

- **3.31** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 12 during the hours specified in column 4 of Schedule 12, unless that vehicle is a Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle.
- **3.32** No person shall cause or permit any Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle in a Parking Place specified in columns 1, 2 and 3 of Schedule 12 during the hours specified in column 4 of Schedule 12 to wait for longer than the period of time specified in column 5 of Schedule 12.

3.33 No person shall cause or permit any Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle in a Parking Place specified in columns 1, 2 and 3 of Schedule 12 during the hours specified in column 4 of Schedule 12 to return to the same Parking Place within the period of time specified in column 6 of Schedule 12.

SHARED USE PARKING PLACE – NO WAITING/NO LOADING & DISABLED BADGE HOLDER PARKING

- **3.34** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 13 during the hours specified in column 4 of Schedule 13.
- **3.35** No person shall cause or permit any vehicle other than a Disabled Persons Vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 13 during the hours specified in column 5 of Schedule 13.
- **3.36** No person shall cause or permit a Disabled Persons Vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 13 during the hours specified in column 5 of Schedule 13 for longer than the period of time specified in column 6 of Schedule 13.
- **3.37** No person shall cause or permit a Disabled Persons Vehicle waiting in the Parking Places specified in columns 1, 2 and 3 of Schedule 13 during the hours specified in column 5 of Schedule 13 to return to the same Parking Place within the period of time specified in column 7 of Schedule 13.

SHARED USE PARKING PLACE – NO WAITING/NO LOADING & GOODS VEHICLE LOADING BAY

- **3.38** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 14 during the hours specified in column 4 of Schedule 14.
- **3.39** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 14 during the hours specified in column 5 of Schedule 14, unless that vehicle is a Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle.
- **3.40** No person shall cause or permit any Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle in the Parking Places specified in columns 1, 2 and 3 of Schedule 14 during the hours specified in column 5 of Schedule 14 to wait for longer than the period of time specified in column 6 of Schedule 14.
- **3.41** No person shall cause or permit any Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle in a Parking Place specified in columns 1, 2 and 3 of Schedule 14 during the hours specified in column 5 of Schedule 14 to return to the same Parking Place within the period of time specified in column 7 of Schedule 14.

SHARED USE PARKING PLACE - NO WAITING EXCEPT TAXIS & LOADING BAY

- **3.42** No person shall cause or permit any vehicle other than a Taxi to wait in the lengths of road specified in columns 1, 2 and 3 of Schedule 15 during the hours specified in column 4 of Schedule 15.
- 3.43 No person shall cause or permit any vehicle to wait in the Parking Place specified in columns 1, 2 and 3 of Schedule 15 during the hours specified in column 5 of Schedule 15, unless that vehicle is waiting for the purpose of loading or unloading goods from that vehicle.
- **3.44** No person shall cause or permit any vehicle waiting for the purpose of loading or unloading goods from that vehicle in the Parking Places specified in columns 1, 2 and 3 of Schedule 15 during the hours specified in column 5 of Schedule 15 to wait for longer than the period of time specified in column 6 of Schedule 15.
- **3.45** No person shall cause or permit any vehicle waiting for the purpose of loading or unloading goods from that vehicle in the Parking Places specified in columns 1, 2 and 3 of Schedule 15

during the hours specified in column 5 of Schedule 15 to return to the same Parking Place within the period of time specified in column 7 of Schedule 15.

SHARED USE PARKING PLACE – NO WAITING EXCEPT TAXIS & GOODS VEHICLE LOADING BAY

- **3.46** No person shall cause or permit any vehicle other than a Taxi to wait in the lengths of road specified in columns 1, 2 and 3 of Schedule 16 during the hours specified in column 4 of Schedule 16.
- **3.47** No person shall cause or permit any vehicle to wait in the Parking Place specified in columns 1, 2 and 3 of Schedule 16 during the hours specified in column 5 of Schedule 16, unless that vehicle is a Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle.
- **3.48** No person shall cause or permit any Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle in the Parking Places specified in columns 1, 2 and 3 of Schedule 16 during the hours specified in column 5 of Schedule 16 to wait for longer than the period of time specified in column 6 of Schedule 16.
- **3.49** No person shall cause or permit any Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle in the Parking Places specified in columns 1, 2 and 3 of Schedule 16 during the hours specified in column 5 of Schedule 16 to return to the same Parking Place within the period of time specified in column 7 of Schedule 16.

SHARED USE PARKING PLACE - BUS PARKING AND GOODS VEHICLE LOADING BAY

- **3.50** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 17 during the hours specified in column 4 of Schedule 17, unless that vehicle is:
 - (a) A Goods Vehicle waiting for the purpose of loading or unloading goods from that vehicle provided it does not wait for longer than the period of time specified in column 5 of Schedule 17; or
 - (b) A Bus provided that it does not wait for longer than the period of time specified in column 6 of Schedule 17.
- **3.51** No person shall cause or permit any vehicle waiting in the Parking Places specified in columns 1, 2 and 3 of Schedule 17 during the hours specified in column 4 of Schedule 17 to return to the same Parking Places within the period of time specified in column 7 of Schedule 17.

SHARED USE PARKING PLACE – PERMIT HOLDERS OR PAY AND DISPLAY PARKING

- **3.52** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 18 during the hours specified in column 4 of Schedule 18 unless:
 - (a) that vehicle is displaying a valid Parking Permit for the Zone specified in column 5 of Schedule 18; or
 - (b) the appropriate charge for the length of stay, as specified in Schedule A, has been paid.
- **3.53** The charge described in Article 3.52 shall be payable by:
 - (a) the insertion into a Parking Meter which relates to the Parking Place of coins (or notes where such a facility is available); or
 - (b) credit or debit card at a Parking Meter which relates to the Parking Place (where such a facility is available); or
 - (c) use of a pay by phone, pay by text or pay by app system (where such a facility is available).

- **3.54** Where a Ticket has been issued from a Parking Meter it must be displayed; in the case of a vehicle fitted with a transparent windscreen, so that it is facing upwards and can be entirely and easily seen from outside the vehicle; or in the case of a vehicle which is not fitted with a transparent windscreen, in a conspicuous position on the vehicle. Multiple Tickets' shall not be displayed.
- **3.55** The time at which the length of stay paid for will expire shall be as specified:
 - (a) on the Ticket issued by the Parking Meter; or
 - (b) on a hand-held device which indicates when a charge has been paid by phone, text or app
- **3.56** A Ticket shall cease to be valid at the time specified on it.
- **3.57** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 18 during the hours specified in column 4 of Schedule 18 after the expiry of the length of stay paid for.
- **3.58** The length of stay paid for shall not be extended beyond the initial period (i.e. no meter feeding), for the avoidance of doubt this provision applies even if such an extension would not cause the vehicle to wait for a period of time longer than the maximum stay period specified in column 6 of schedule 18.
- **3.59** No person shall cause or permit any vehicle to wait in the Parking Places specified in columns 1, 2 and 3 of Schedule 18 during the hours specified in column 4 of Schedule 18 for longer than the period of time specified in column 6 of Schedule 18 unless that vehicle is displaying a valid Parking Permit for the Zone specified in column 5 of Schedule 18.
- **3.60** No person shall cause or permit any vehicle waiting in the Parking Places specified in columns 1, 2 and 3 of Schedule 18 during the hours specified in column 4 of Schedule 18 to return to the same Parking Place within the period of time specified in column 7 of Schedule 18 unless that vehicle is displaying a valid Parking Permit for the Zone specified in column 5 of Schedule 18.

PART FOUR – PARKING PERMITS

APPLICATION FOR PARKING PERMITS

- 4.1 An application for a Parking Permit must be made in the manner specified by the Council.
- **4.2** The Council may require an applicant for a Parking Permit to produce such evidence as considered necessary to verify the information provided as part of the application for a Parking Permit.

ELIGIBILITY FOR PARKING PERMITS

- **4.3** Any persons whose place of residence is within the following locations may be issued with a maximum of two Parking Permits (one Residents Parking Permit and one Visitors Parking Permit) for parking within Zone A:
 - (a) East Street, Hereford between St Ethelbert Street and Offa Street (inclusive of numbers 23 East Street to 89 East Street and 1 Pulling Mews to 5 Pulling Mews)
 - (b) Barroll Street
- **4.4** Any persons whose place of residence is within the following locations may be issued with a maximum of two Parking Permits (one Residents Parking Permit and one Visitors Parking Permit) for parking within Zone 2:
 - (a) Castle Street
 - (b) Cantilupe Street
 - (c) St Ethelbert Street

- **4.5** A Residents Parking Permit may only be issued to the owner of the vehicle to which the Parking Permit will apply.
- **4.6** A Parking Permit may only be issued in respect of vehicles of the following classes: Passenger Vehicles, Light Goods Vehicles and Motor Cycles.
- **4.7** Any business which operates from premises in Castle Street, Cantilupe Street or St Ethelbert Street may, at the discretion of the Council, be issued with one or more Business Parking Permits for parking within Zone 2..

ISSUE OF PARKING PERMITS

- **4.8** On receipt of an application made under the provisions of this Order the Council, upon being satisfied that the applicant is eligible and meets all its relevant requirements may issue a Parking Permit.
- **4.9** There will be a charge of £30 for the issue of each Residents Parking Permit and Visitors Parking Permit, valid for one year.
- **4.10** A duplicate Parking Permit may be issued by the Council if the original Parking Permit has been lost, stolen, or becomes mutilated, defaced, faded discoloured or otherwise illegible.
- **4.11** There will be a charge of £10 for the issue of each duplicate Residents Parking Permit and Visitors Parking Permit.
- **4.12** The Council reserves the right to vary the policy, charges and terms for the issue of a Parking Permit as it considers appropriate and will provide written notice of any such variation as the Council considers appropriate.
- **4.13** Notwithstanding the preceding articles, the issuing of a Parking Permit is at the complete discretion of the Council and exceptional issues of Parking Permits may be undertaken as the Council considers appropriate.

VALIDITY OF PARKING PERMITS

- 4.14 A Parking Permit shall only be valid for use:
 - (a) within the streets or zone in respect of which it was issued
 - (b) where the Parking Permit is a Residents Parking Permit with the vehicle to which the Parking Permit applies
 - (c) where the Parking Permit is a Business Permit for a maximum of two hours at a time
- **4.15** A Parking Permit shall cease to be valid in the following circumstances:
 - (a) After the expiry date specified on it
 - (b) The Parking Permit holder ceases to occupy the dwelling in respect of which the Parking Permit was issued
 - (c) The Parking Permit holder ceases to be the owner of the vehicle in respect of which the Parking Permit was issued
 - (d) The vehicle in respect of which the Parking Permit was issued has been adapted, modified or used in such a manner that it ceases to be a vehicle of a class eligible for a Parking Permit as specified in Article 4.6
 - (e) The withdrawal of the Parking Permit by the Council
 - (f) A duplicate Parking Permit is issued by the Council

WITHDRAWAL AND SURRENDER OF PARKING PERMITS

- **4.16** A Parking Permit holder may surrender a Parking Permit to the Council at any time.
- **4.17** A Parking Permit holder must surrender a Parking Permit to the Council in the circumstances specified in article 4.15 (b) to (f).

4.18 The Council may serve notice of the withdrawal of a Parking Permit in writing to the Parking Permit holder at the address given on the application or at any other address believed to be the Parking Permit holders residence or place of business; on receipt of this notice the Parking Permit holder shall surrender the Permit to the Council within 48 hours.

FORM OF PARKING PERMITS

- **4.19** A Parking Permit shall be in writing and shall include the following particulars:
 - (a) Where the Parking Permit is a Residents Parking Permit the registration mark of the vehicle to which the Parking Permit applies
 - (b) The expiry date of the Parking Permit
 - (c) An indication that the Parking Permit was issued by the Council

DISPLAY OF PARKING PERMITS

4.20 A Parking Permit must be displayed in the case of a vehicle fitted with a transparent windscreen on the inside surface of the windscreen so that it is facing upwards and can be entirely and easily seen from outside the vehicle or in the case of a vehicle not fitted with a transparent windscreen, in a conspicuous position on the vehicle.

PART FIVE – EXEMPTIONS

GENERAL EXEMPTIONS

- **5.1** Nothing in this Order shall prohibit any vehicle from waiting for as long as reasonably necessary in the following circumstances:
 - (a) The vehicle is directed to wait by or with the permission of a police officer or Civil Enforcement Officer in uniform
 - (b) The vehicle is being used for emergency services purposes
 - (c) To prevent a road traffic collision
 - (d) The vehicle cannot be moved due to an unavoidable breakdown
 - (e) the vehicle, not being a Passenger Vehicle, is waiting only for so long as may be reasonably necessary to enable it to be used for the purpose of any building operation, demolition or excavation or the maintenance, improvement or reconstruction of any said lengths of road or the laying erection, alteration, removal or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telegraphic line or traffic sign in any said lengths of road
 - (f) the vehicle, not being a Passenger Vehicle, is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository, provided that notice is given twenty-four hours in advance to the Council and their consent is obtained and any conditions imposed are complied with
 - (g) The vehicle is being used for the purpose of delivering or collecting postal packets
 - (h) The vehicle is a bridal vehicle or funeral cortege vehicle being used solely in connection with the transportation of the bride or groom at weddings or the deceased and immediate family of the deceased for funerals at St. Francis Xavier's Church Hereford, provided that the vehicle is waiting in Broad Street between 76 metres south of East Street and its junction with Palace Yard except where no stopping restrictions apply

NO WAITING EXEMPTIONS

- **5.2** Nothing in articles 2.1 or 2.2 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is waiting for the purposes of loading or unloading that vehicle, provided the loading/unloading is continuous and being undertaken in a timely manner, the goods being loaded/unloaded cannot reasonably be carried other than by means of a vehicle, the vehicle is waiting adjacent to where the goods are being loaded/unloaded from/to and the length of time the vehicle is waiting for is reasonable
 - (b) To allow the picking up or setting down of passengers
 - (c) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity;
 - (d) The vehicle is waiting for the purpose of removing an obstruction to traffic
 - (e) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (f) The vehicle is a Disabled Persons Vehicle, provided the vehicle does not wait for longer than three hours and at least one hour has elapsed following a previous period of waiting by the vehicle in the same road or part of a road
 - (g) The vehicle is displaying a valid temporary parking restriction dispensation permit issued by the Council but such permit cannot be used where a prohibition of loading also applies
- **5.3** Nothing in article 5.2 shall apply to a vehicle waiting in the lengths of road specified in schedule 4 or specified in columns 1, 2 and 3 of Schedule 5 during the hours specified in column 4 of Schedule 5.

NO WAITING EXCEPT TAXIS EXEMPTIONS

- **5.4** Nothing in article 2.3 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) To allow the picking up or setting down of passengers
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity

NO LOADING EXEMPTIONS

- **5.5** Nothing in articles 2.1, 2.2 2.4 or 2.5 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) To allow the picking up or setting down of passengers
 - (b) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (c) The vehicle is waiting for the purpose of removing an obstruction to traffic
 - (d) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity

USE OF PARKING PLACE EXEMPTIONS

- **5.6** Nothing in articles 3.2, 3.4 or 3.6 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity

LIMITED WAITING FOR BUSES EXEMPTIONS

- **5.7** Nothing in articles 3.10, 3.11 or 3.12 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is displaying a valid temporary parking restriction dispensation permit issued by the Council

PERMIT PARKING EXEMPTIONS

- **5.8** Nothing in articles 3.13 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) To allow the picking up or setting down of passengers
 - (b) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (c) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (d) The vehicle is a wedding car or hearse and is being used in connection with a wedding or funeral cortege in the immediate vicinity
 - (e) The vehicle is displaying a valid temporary parking restriction dispensation permit issued by the Council

PERMIT PARKING OR LIMITED WAITING EXEMPTIONS

- **5.9** Nothing in articles 3.14 or 3.15 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a Disabled Persons Vehicle
 - (b) To allow the picking up or setting down of passengers
 - (c) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (d) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (e) The vehicle is a wedding car or hearse and is being used in connection with a wedding or funeral cortege in the immediate vicinity
 - (f) The vehicle is displaying a valid temporary parking restriction dispensation permit issued by the Council

DISABLED BADGE HOLDER PARKING EXEMPTIONS

- **5.10** Nothing in articles 3.16, 3.17 or 3.18 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (b) The vehicle is a wedding car or hearse and is being used in connection with a wedding or funeral cortege in the immediate vicinity

PAY AND DISPLAY PARKING EXEMPTIONS

- **5.11** Nothing in articles 3.19, 3.20, 3.21, 3.22, 3.23, 3.24, 3.25, 3.26 or 3.27 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a Disabled Persons Vehicle

- (b) To allow the picking up or setting down of passengers
- (c) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
- (d) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
- (e) The vehicle is displaying a valid temporary parking restriction dispensation permit issued by the Council

LOADING BAY EXEMPTIONS

- **5.12** Nothing in articles 3.28, 3.29 or 3.30 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is displaying a valid temporary parking restriction dispensation permit

GOODS VEHICLE LOADING BAY EXEMPTIONS

- **5.13** Nothing in articles 3.31, 3.32 or 3.33 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is displaying a valid temporary parking restriction dispensation permit

SHARED USE PARKING PLACE – NO WAITING/NO LOADING & DISABLED BADGE HOLDER PARKING EXEMPTIONS

- **5.14** Nothing in article 3.34 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) To allow the picking up or setting down of passengers
 - (b) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity;
 - (c) The vehicle is waiting for the purpose of removing an obstruction to traffic
 - (d) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
- **5.15** Nothing in articles 3.35, 3.36 and 3.37 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (b) The vehicle is a wedding car or hearse and is being used in connection with a wedding or funeral cortege in the immediate vicinity

SHARED USE PARKING PLACE – NO WAITING/NO LOADING & GOODS VEHICLE LOADING BAY

- **5.16** Nothing in article 3.38 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) To allow the picking up or setting down of passengers
 - (b) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity;
 - (c) The vehicle is waiting for the purpose of removing an obstruction to traffic

- (d) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
- **5.17** Nothing in articles 3.39, 3.40 and 3.41 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is displaying a valid temporary parking restriction dispensation permit

SHARED USE PARKING PLACE - NO WAITING EXCEPT TAXIS & LOADING BAY

- **5.18** Nothing in article 3.42 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) To allow the picking up or setting down of passengers
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
- **5.19** Nothing in articles 3.43, 3.44 and 3.45 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is displaying a valid temporary parking restriction dispensation permit

SHARED USE PARKING PLACE – NO WAITING EXCEPT TAXIS & GOODS VEHICLE LOADING BAY

- **5.20** Nothing in article 3.46 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) To allow the picking up or setting down of passengers
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
- **5.21** Nothing in articles 3.47, 3.48 and 3.49 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (c) The vehicle is displaying a valid temporary parking restriction dispensation permit

SHARED USE PARKING PLACE - BUS PARKING AND GOODS VEHICLE LOADING BAY EXEMPTIONS

- **5.22** Nothing in articles 3.50 or 3.51 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (b) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity

- (c) The vehicle is displaying a valid temporary parking restriction dispensation permit issued by the Council
- **5.23** Nothing in articles 3.52, 3.53, 3.54, 3.55, 3.56, 3.57, 3.58, 3.59 or 3.60 shall apply to a vehicle waiting for as long as necessary in the following circumstances:
 - (a) The vehicle is a Disabled Persons Vehicle
 - (b) To allow the picking up or setting down of passengers
 - (c) The vehicle is a cleaning or refuse vehicle collecting rubbish in the immediate vicinity
 - (d) The vehicle is a liveried utility company vehicle being used in connection with works of that utility in the immediate vicinity
 - (e) The vehicle is displaying a valid temporary parking restriction dispensation permit issued by the Council

PART SIX – CONTRAVENTION & REVOCATIONS

CONTRAVENTION

6.1 Any person or vehicle failing to comply with the provisions of this Order shall be in contravention of it and a penalty charge shall be payable.

REVOCATIONS

- **6.2** The following traffic regulation orders shall be revoked or varied as specified below and any other traffic regulation order shall be revoked so far as it affects the lengths of road(s) affected by this Order:
 - (a) Revoked in their entirety
