Commentary on sports halls supply:

- There are approximately 85 sports halls in the sub region on 60 hall sites. This represents 15.6% of the total number of sports halls in the region. Herefordshire has the largest number of sports halls with 16 with Redditch and Wyre Forest having the lowest at 8 each.
- When supply is expressed as the number of courts there are 325 badminton courts in the sub region which is equivalent to 248 courts when hours available in the peak period is factored in. Herefordshire has 66 courts (equivalent to 48 when available hours factored in) to Redditch with 30 (23 when available hours factored in).
- In terms of total supply which is expressed as visits per week in the peak period there are potentially 50.242 visits potentially available in the peak

period. This is approximately 15.1% of total capacity as expressed in vpwpp. Herefordshire has 19.5% of this capacity (9,795 vpwpp) while Redditch has 9.3% (4,679 vpwpp).

• In terms of courts per 10,000 Malvern Hills has the highest level of provision at 7.36 courts per 10,000 while Wychavon has the lowest at 3.03 courts per 10,000. This compares to a regional average of 3.83 courts per 10,000.

Commentary on demand:

- In terms of total demand which is expressed as the total number of visits demanded per week in the peak period (vpwpp) there is a total of 32,419 visits demanded in the sub region which is 13% of the total demand in the region. The Local Authority with the highest demand is Herefordshire with 7,675 vpwpp which is 23.7% of the demand in the sub region while Malvern Hills is the lowest with 3,136 vpwpp or 9.7% of the sub regional demand.
- When demand is expressed as the number of courts (with a comfort factor included) this equates to 200 courts and varies from 47 courts in Herefordshire to 19.4 courts in Malvern Hills.

Commentary on supply/demand balance:

- Comparing overall demand with supply across the Sub region, the resident population is estimated to generate a demand for a minimum of 200 courts. This compares to a current supply of 248 courts, giving a supply balance of +48 courts. In terms of the supply/demand balance Herefordshire, Wychavon, Wyre Forest and Redditch have a balanced supply/demand while in Bromsgrove, Worcester and Malvern Hills supply is greater than demand.
- **Note:** This provides only a 'global' view of provision in the Borough, and does not take account of the location of facilities in relation to demand; how accessible facilities are to the resident population (by car and on foot); nor does it take account of facilities in adjoining Districts

Commentary on satisfied demand

- The demand for sports halls in the sub region currently being met by supply varies from Bromsgrove with 96.6% of demand satisfied to Wyre Forest with 93% of demand satisfied. All Local Authorities in the sub region have higher levels of satisfied demand than the regional average of 90.5%.
- The percentage of demand satisfied by people travelling by car is relatively high, varying from 91.3% in Malvern Hills and Wychavon to 81.1% in Worcester, and probably reflects the rural nature of the sub region. The regional average is 81.7%.
- There is a variation in the percentage of demand that is retained by individual Local Authorities with Worcester City and Wyre Forest retaining 96.2% and 93.9% of demand respectively while Bromsgrove, Malvern Hills and Wychavon retain approximately 77% (i.e. exports 23%) of demand each.

Commentary on unmet demand:

- Unmet demand as a percentage of total demand varies from 9.4% in Herefordshire to 3.4% in Bromsgrove. This compares to a regional average of 9.5%
- Unmet demand can be expressed as an equivalent in badminton courts (with comfort factor) and this varies from 4.4 courts in Herefordshire to less than 1 court in Bromsgrove. A standard sports hall is 4 courts and unmet demand is spread thinly across the sub region.
- The majority of unmet demand is due to people living outside a catchment area (eg 20 minute drive/walk time) rather than because of a lack of capacity i.e. sports halls are full although there is a significant variation with 12.3% of unmet demand not being met in Herefordshire due to lack of capacity. The majority of unmet demand due to lack of capacity in Herefordshire is from residents that have access to a car and the implications is that residents will not travel to alternative facilities due to the distances to travel.

Commentary on used capacity:

- In terms of overall capacity (i.e. how full sports halls are) the percentage of overall capacity used varies from 75.3% in Wyre Forest to 34.8% in Malvern Hills. The regional average is 67.2% while 80% is considered to be full when a comfort factor is applied.
- The percentage of visits imported varies from 32.9% in Bromsgrove to 2.4% in Herefordshire. Consequently the percentages for the percentage of visits retained are 67.1% and 97.6% respectively.

Comments on relative share:

- Relative share helps to show which areas have a better / worse share of facilities compared to everyone else. It takes into account the size and availability of facilities as well as travel modes. It helps to establish whether a particular area has less than, or more than its 'fair share' of facilities compared to the national average.
- There is a wide variation in relative score with Malvern Hills significantly above the national average (score of 100) with a score of 178, while Redditch is below the national average with a scores of -3. This compares to a regional average of 100.
