- Part B should be used to comment on the soundness of a modification. Part B continuation forms should be used for each additional modification commented on.
- Please ensure that you send the Part A form together with all Part B continuation forms when submitting your comments.
- Please note that the consultation is only about the proposed Main Modifications and <u>not</u> other aspects of the plan. Please do not repeat any previous comments made on the Travellers DPD as these have already been considered by the Planning Inspector.

- Positively prepared. This means that the Plan should seek to meet objectively assessed needs and infrastructure requirements where it is reasonable to do so and where this is consistent with achieving sustainable development.
- **Justified.** This means that the Plan should be the most appropriate strategy, considered against reasonable alternatives.
