#### COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL

# (EAST STREET, HEREFORD) (PROHIBITION OF DRIVING EXCEPT FOR ACCESS & TAXIS) ORDER 2015

The County of Herefordshire District Council ("the Council") in exercise of its powers under sections 1 and 2 Road Traffic Regulation Act 1984 (referred to as "the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

- This Order shall come into operation on the 30<sup>th</sup> day of January 2015 and may be cited as the County of Herefordshire District Council (East Street, Hereford) (Prohibition of Driving Except for Access & Taxis) Order 2015
- 2. In this Order:-
  - "Hackney Carriage Vehicle" means a vehicle (with driver in attendance of the vehicle at all times) plying for hire validly licensed by the Council as a hackney carriage and displaying an authorised plate and has the same meaning assigned to it as stated in the Local Government (Miscellaneous Provisions) Act 1976
- 3. Save as provided in Article 3 of this Order no person shall, except upon the direction or with the permission of a police officer, cause or permit any vehicle to proceed along the lengths of road as stated on the attached Schedule 1 and as shown for identification purposes only on the enclosed plan.
- 4. The restrictions imposed by Article 2 above shall not apply when vehicles are being used in connection with the following purposes:-
  - (i) fire brigade ambulance or police
  - (ii) statutory undertakers
  - (iii) hackney carriage vehicle
  - (iv) demolition or delivery of materials or plant for building work
  - (v) delivering or collecting postal packets to premises
  - (vi) bullion vehicles
  - (vii) street cleansing and refuse collection or for purposes associated with the maintenance of the highway, street furniture or fabric of the highway
  - (viii) removing furniture and effects from premises provided notice is given twentyfour hours in advance to the police and their consent is obtained and such reasonable conditions as the police may impose are complied with
  - (ix) vehicles requiring access to premises or land fronting said sides of lengths of road to which there is not a satisfactory alternative means of vehicular access
  - (x) pedal cycles travelling in U80005 East Street in an easterly direction only
- 5. The Council are satisfied that, for preserving or improving the amenities of the lengths of roads referred to in Article 2 of this Order by restricting the use on the said

- lengths of roads by motor vehicles subject to Article 3 above, it is requisite that Section 3(1) of the 1984 Act should not apply in relation to this Order.
- 6. Any provisions of previous traffic regulation orders that are contrary to the provisions hereto as stated in Schedule 2 hereto as regards the lengths of road subject to this Order will be revoked on the coming into operation of this Order.
- 7. Reference to any statutory provision herein shall include reference to any statutory modification substitution or re-enactment thereof.
