To introduce a One-Way Traffic Order where the only direction of travel permitted is Southeast Bound on the following stretch of road;

• C1144 Lumber Lane - Between its junction with A465 and its junction with A4103.


The County of Herefordshire District Council, known as Herefordshire Council, ("the Council") in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (referred to as "the Act"), and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act and of all other enabling powers hereby makes the following Order:

- This Order shall come into operation on the day of 2020 and may be cited as
 THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (C1144 LUMBER LANE, HEREFORD) (ONE-WAY TRAFFIC) ORDER 2020.
- 2. Save as provided in Article 3 of this Order no person shall, except upon the direction of or permission from a police officer in uniform or direction of or permission from a civil enforcement officer appointed under the provisions of Section 76 Traffic Management Act 2004 (if authorised to do so by any statutory provisions then in force), cause or permit any vehicle, which for the avoidance of doubt includes pedal cycles, to proceed along the C1144 Lumber Lane, Hereford between its junction with A465 and its junction with A4103, other than in a south-easterly direction.
- 3. The restrictions imposed by Article 2 of this Order shall not apply to the following vehicles:
 - a) Emergency service vehicles (Police, Fire Brigade or Ambulance)
- 4. References to any statutory provision herein shall include reference to any statutory modification or re-enactment thereof.

STATEMENT OF REASONS FOR PROPOSING

THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (C1144 LUMBER LANE, HEREFORD) (ONE-WAY TRAFFIC)

ORDER 2020

The implementation of the proposed One-Way Traffic Order under Section 1 & 2 of the Road Traffic Regulation Act 1984 is necessary for the following reasons:

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising with particular regard to the very poor visibility for vehicles currently travelling north and attempting to pull out onto the A465
- For preserving or improving the amenity of the area through which the road runs.
- To prevent two-way traffic on Lumber Lane due to lack of passing places along its length

The Council reserves the right to produce an amended or further statement in the context of any public enquiry or judicial proceedings to these proposals.
