1. Would you confirm whether the Garway Parish Policies Map forms part of the NDP as the key shows policies in the Core Strategy. Should the village Policies Maps replace the Proposals Maps in the Plan itself?

2. Would HC provide an update on the tables in paragraphs 3.3 - 3.4 of the Plan on housing commitments and the residual target. A map showing the locations of the sites would be helpful.

1) The Garway parish policies map is part of the development plan and this map will form an insert into the overall county map. This is why it shows policies from the Core Strategy as well as the NDP. This is a standard approach we have used on all our NDPs.

2) Attached are two maps detailing locations of commitments as requested.

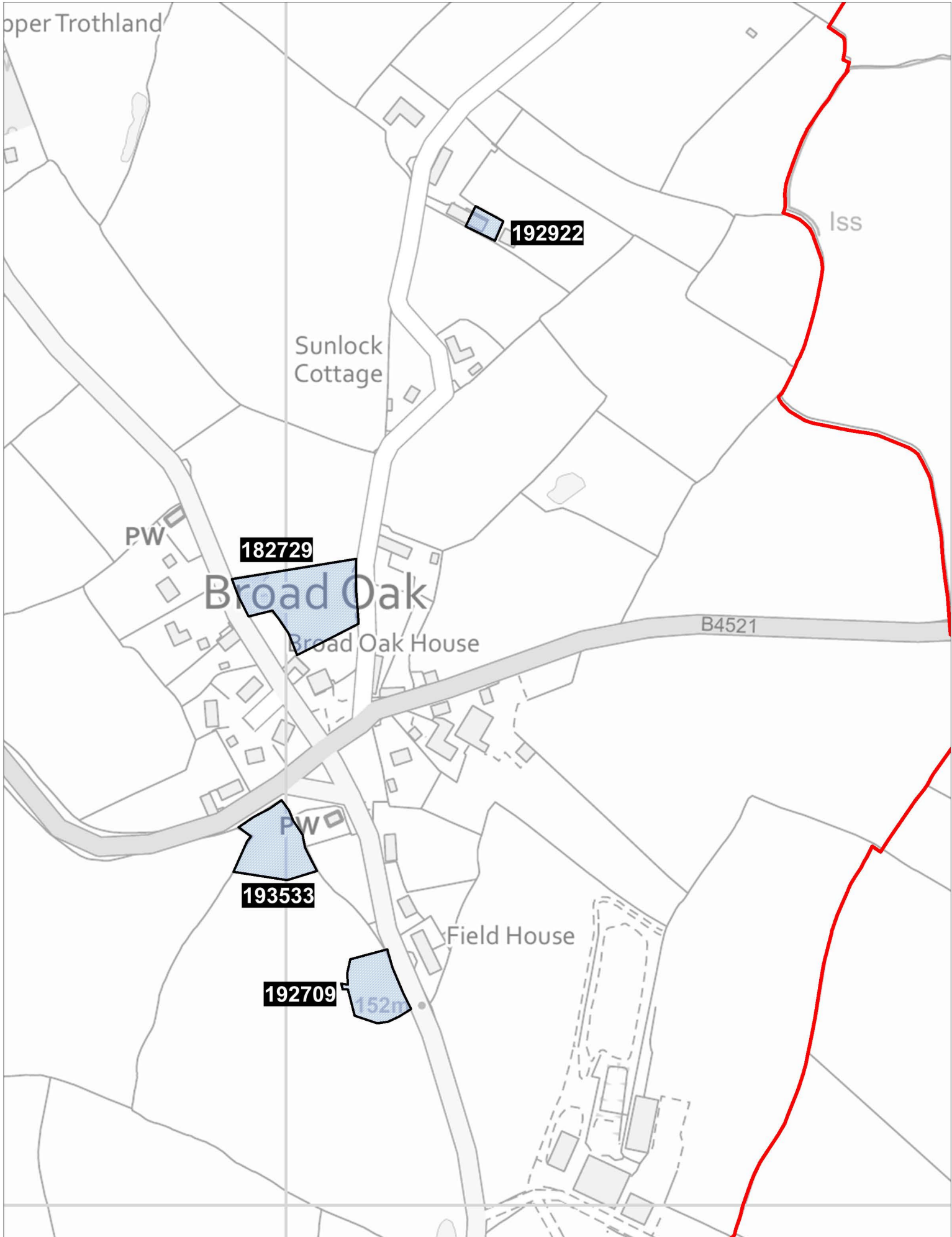
