
APPLICATION FORM FOR A MODIFICATION TO THE DEFINITIVE MAP AND STATEMENT WILDLIFE AND COUNTRYSIDE ACT 1981

hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Upgrading the public footpath Walford Footpath 41 which runs from Point A on the application map (OSGR SO 5841 1922), where Walford Bridleway 39 joins with Walford Footpath 41, to Point D (OSGR SO 5853 1890), the U70408 (Leys Hill Road), to a public bridleway.
- b) Upgrading the public footpath Walford Footpath 42 which runs from Point B on the application map (OSGR SO 5839 1915), where Walford Footpath 41 joins with Walford Footpath 42, to Point C (OSGR SO 5828 1895), the U70408 (Leys Hill Road), to a public bridleway.
- c) Adding the public bridleway which runs from Point E on the application map (OSGR SO 5860 1912), on Walford Bridleway 39, to Point F (OSGR SO 5870 1919), where the route meets Walford Bridleway 45A.
- d) Upgrading part of the public footpath Walford Footpath 46 from Point G on the application map (OSGR SO 5896 1913), where Walford Footpath 46 crosses Walford Bridleway 45A, to Point H (OSGR SO 5885 1897), the junction with the U70408 (Leys Hill Road), to a public bridleway.
- e) Upgrading the public footpath Walford Footpath 102 which runs from Point J on the application map (OSGR SO 5828 1886), the U70408 (Leys Hill Road), to Point K (OSGR SO 5824 1880), the B4234 (From Combe Lodge Access to Beaufort Lodge), to a public bridleway.


