That no person shall drive a motor vehicle at a speed exceeding 40mph along the following lengths of road:

B4362 from a point 168 meters east of its junction with C1011 and C1023 to a point 900m west of that junction.

This Order shall come into operation on 1st October 2021

ROAD TRAFFIC REGULATION ACT 1984

HEREFORDSHIRE COUNCIL (B4362, COOMBES MOOR) (40MPH SPEED LIMIT) ORDER 2021

The County of Herefordshire District Council, known as Herefordshire Council, under paragraph 84 of the Road Traffic Regulation Act of 1984 (referred to as "the Act"), after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and of all other enabling powers hereby makes the following Order:


- 1. This Order shall come into operation on 1st October 2021 and may be cited as (B4362, COOMBES MOOR) (40MPH SPEED LIMIT) ORDER 2021".
- 2. For the purposes of paragraph 84 of the said Act No person shall drive a motor vehicle at a speed in excess of **40mph** on the following stretches of road;
 - **B4362** from a point 168 meters east of its junction with C1011 and C1023 to a point 900m west of that junction.
- 3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
- 4. In accordance with Part IV of Schedule 9 of the Act, any previous Speed Limit Orders relating to the lengths of road referred to in this Order are hereby revoked on the coming into operation of this Order.
- 5. References to any statutory provision herein shall include reference to any statutory modification substitution or re-enactment thereof.

HEREFORDSHIRE COUNCIL STATEMENT OF REASONS FOR PROPOSING

(B4362, COOMBES MOOR) (40 M.P.H SPEED LIMIT) ORDER 2021

The implementation of the proposed speed limits under section 84 of the Road Traffic Regulation Act 1984 is necessary for the following reasons:

- To ensure the expeditious, safe and convenient movement of vehicles through Coombes Moor
- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising
 - To ensure that the speed limit is an appropriate distance from the crossroad junction between B4362, C1011 and C1023
- To ensure that drivers of motor vehicles have time to decrease their speed prior to entering the village of Combe Moor

The Council reserves the right to produce an amended or further statement in the context of any public enquiry or judicial proceedings to these proposals.
