Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 has made the above-named order the effect of which will be:

That in the village of Pembridge the existing 30mph Speed Limit Order be revoked in full and for the same extent of that 30mph speed limit no person shall drive a motor vehicle at a speed exceeding 20mph.

This Order shall come into operation on 15th October 2021.


#### HEREFORDSHIRE COUNCIL (A44 AND VARIOUS SIDE ROADS, PEMBRIDGE) (20MPH SPEED LIMIT) ORDER 2021

The County of Herefordshire District Council, known as Herefordshire Council, under paragraph 84 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (referred to as "the Act"), and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and of all other enabling powers hereby makes the following Order:

- 1. This Order shall come into operation on 15 th October 2021 and may be cited as HEREFORDSHIRE COUNCIL (A44 AND VARIOUS SIDE ROADS, PEMBRIDGE) (20MPH SPEED LIMIT) ORDER 2021
- 2. For the purposes of paragraph 84 of the Act No person shall drive a motor vehicle at a speed in excess of **20mph** on the following stretches of road:
  - A44 from its junction with C1032 for a distance of 436m in an easterly direction
  - A44 from its junction with C1032 for a distance of 437m in a westerly direction
  - C1032 from its junction with A44 for a distance of 400m in a northerly direction
  - U91422 from its junction with C1032 to the limit of its adoption
  - U91421 from its junction with C1032 to the limit of its adoption
  - U91425 from its junction with A44 to its junction with C1083
  - **C1083** from its junction with A44 for a distance of 455m in a south-westerly direction
  - U91424 from its junction with U91423 to the limit of its adoption
  - U91423 from its junction with C1083 to its junction with A44
  - U91427 from its junction with C1083 to the limit of its adoption
- 3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
- 4. In accordance with Part IV of Schedule 9 of the Act, any previous Speed Limit Orders relating to the lengths of road referred to in this Order are hereby revoked on the coming into operation of this Order.
- 5. References to any statutory provision herein shall include reference to any statutory modification substitution or re-enactment thereof.

### STATEMENT OF REASONS FOR PROPOSING

# HEREFORDSHIRE COUNCIL (A44 AND VARIOUS SIDE ROADS, PEMBRIDGE) (20MPH SPEED LIMIT) ORDER 2021

The implementation of the proposed speed limit under Section 84 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 is necessary for the following reasons:

For avoiding danger to persons or other traffic using the road or any other road or preventing the likelihood of any such danger arising

For preserving and improving the amenity of the area through which the road runs

Ensure the expeditious, safe, and convenient movement of vehicles through the area concerned

To ensure that the 20mph speed limit covers all development within Pembridge Village including the local school

To compliment the edge of carriageway lining and gateway features currently present at the village
