Notice of Submission for Examination

Planning and Compulsory Purchase Act 2004 Town and Country Planning (Local Planning) (England) Regulations 2012 Regulation 22

Notice is hereby given, in accordance with Regulation 22(3) of the Town and Country Planning (Local Planning) (England) Regulations 2012, that on 22nd March 2022, Herefordshire Council submitted the *Minerals and Waste Local Plan* ('MWLP' or 'the Plan') to the Secretary of State for an Examination in Public.

The MWLP sets out the council's preferred strategy for meeting the county's minerals and waste needs until 2041. It presents a vision, objectives, spatial strategy, planning policies and allocations for minerals and waste development within Herefordshire. The Plan's main purpose is to provide guidance to developers, local communities and other interested parties on where and when minerals and waste development may be expected over the Plan period, as well as how this will be managed to reduce adverse impacts and maximise benefits.

Once adopted, the MWLP will form part of the statutory development plan and the council will use it, along with the Local Plan Core Strategy, as the starting point for decisions on planning applications for development relating to minerals and waste activities.

Evidence gathering and preparation of the MWLP began in 2016. There have been two call for sites exercises and three rounds of public consultation during its preparation. Comments to the first two rounds of consultation have been used to devise the submission version of the Plan. The Publication Draft MWLP which was consulted on during April/May 2021, has been submitted, with the responses received, along with a 'Schedule of Main Modifications and Minor Changes proposed Pre-Examination' and all other supporting documents. The Inspector will now consider the responses alongside the Plan and the suggested modifications.

None of the edits proposed through the schedule of proposed modifications and minor changes are considered fundamentally to change the aims or objectives of the MWLP overall; they are clarifications either to update the Plan and/or to ensure that the meaning of policy is clear to all using it. The council has taken an approach of erring in favour of defining a change as a main modification where there is any change to policy, such that it can be tested through the Examination. The minor changes relate to rectifying formatting and typographical errors, or constitute simple updates and corrections.
