2. Introduction and Purpose

• Introduction

The National Model Design Code (NMDC) forms part of the Planning Practice Guidance (PPG) and explains the 10 characteristics of good design. Herefordshire Council have produced a set of guidance notes and templates to assist your community to produce a design code for your parish.

Herefordshire Council are encouraging all parish councils with their local communities to produce a design code as part of their neighbourhood plan review. A named officer from the Neighbourhood Planning team will be able to offer support and advice as you work to establish the background context information, the community engagement and survey phase and the production of your Design Code.

• Purpose

The purpose of this Agreement is to form a working relationship between the Parish Council and Herefordshire Council and to confirm:-

a) The level and extent of the technical advice and guidance that Herefordshire Council will provide;

b) How the Parish Council will aim to progress their Design Code as part of their Neighbourhood Development Plan.

5. Obligations for the Parish Council

The Parish Council will:-

Following agreement by the Council of the Neighbourhood Area

Establish a steering group to develop the Design Code with a clear reporting link to the Parish Council via a Terms of Reference.

Arrange an initial meeting of the Parish Council/steering group and invite the support Planning Officer from the Neighbourhood Planning team.

Prepare a Project Plan for the preparation of the Design Code.

The Project Plan would include:-

- An indicative timetable for completion of the Neighbourhood Development Plan;
- The provision of regular updates on progress to the Council via your Neighbourhood Planning Support Officer;
- Programme discussions with the Support Officer at the stage of preparation of the Draft Code.

Following agreement by the Council of the Neighbourhood Area

Draft Code

- Ensure that sufficient community engagement is undertaken to demonstrate baseline data is locally agreed;
- Send a copy of the draft code to support officer for review;
- produce a consultation statement highlighting how the local community have been involved and influenced the decision making.

Final Code

• Provide a digital copy of the final code to the Neighbourhood Planning team.
