1.	Attendance / Apologies / Introductions

2.	Background
	The meeting received a background briefing on historic and present efforts by the statutory agencies, councils, NGOs, water companies and farming sector to restore the Wye to favourable conservation status. The meeting was also appraised of current governance arrangements and the nutrient management plan along with progress on calls by Councils for further actions and faster progress.

3. Terms of Reference The Commissioners considered the terms of reference which had been set by Herefordshire Council Cabinet. It was agreed that Monmouthshire and Forest of Dean would each provide an introductory paragraph explaining their involvement with the Commission. Action: Forest of Dean and Monmouthshire will provide an introductory paragraph for the terms of reference.

4. Review of Nutrient Management Board

Commissioners received a briefing on plans to review the governance arrangements supporting the delivery of the Nutrient Management Plan through the present Nutrient Management Board which is currently constituted as a voluntary body with a voluntary plan. The NMB had been in place for some time now and the formation of the Commission is an opportune time to review the Board and its governance arrangements to ready them for the future needs of the Wye.

Commissioners were advised that whilst a review could be undertaken no one organisation had the power to compel others. Nevertheless it was felt that an independent call for evidence might assist partners by bringing forward well researched and evidenced proposals to create stronger governance and performance management arrangements.

Commissioners also wanted to receive clarity on the legal status of the NMB and its Nutrient Management Plan and requested advice be made available for the next meeting

Action: RJ to circulate a draft call for evidence and legal advice to be commissioned (report progress to the next meeting in November)

5. Farming and Agriculture

The Commission received a briefing on Water Protection Zones (WPZ) which had been declined by DEFRA and led to the creation of the Commission. In particular, attention was drawn to a case study of the Poole Harbour Scheme which had taken three years to design with the farming community before incorporation into a court order. The scheme would take ten years to deliver and would likely see a further ten years pass before benefits are seen, The Scheme had check points at 2024, 2027 and 2030 and if progress had been insufficient would lead to consideration of a WPZ.

Discussions have commenced with Farm Herefordshire, the NFU and CLA on adopting a similar but catchment relevant approach here. Representatives have agreed to meet fortnightly to develop an outline scheme for partners to consider and if agreed developed in detail.

Commissioners were made aware that the President of NFU (National Farmers Union) is visiting in January and agreed work should take place on a joint presentation for that meeting.

The Commission considered how Welsh Farming could be brought into this process and it was decided to evaluate whether Natural Resources of Wales catchment support funding could be used for a capacity building project.

6.	The Farming and Agriculture Supply Chain The Commission received an overview of the Wye Agri Partnership Project to work with the supply chain to reduce Phosphate Pollution. The Commission Agreed to invite the partnership to make a presentation at the next meeting in November. Actions:

7.	The National Policy Framework The Commission was advised of potential regulatory gaps which needed national consideration- these included what restoration looked like in the context of climate change and national challenges relating to food, water and energy security. The Commission also wanted to explore issues relating to farming rules for water and the regulation of poultry flocks below 40000 birds. Policy discussion papers would be brought to future meetings.
8.	The Local Planning Framework Commissioners to identify opportunities within the local planning system for further exploration by the Commission HC preparing a paper on the local plan and enforcement for next meeting
9.	Jesse Norman MP – Call for a five year Plan and Engagement With MPs The meeting considered a paper which compared the terms of reference for the Commission with Jesse Norman MPs call for a five year action plan for the Wye at a meeting in July. A discussion took place on linking local and national political representation to work together on river restoration. Chief Exec Paul Walker to send to Jesse Norman MP
