RE: Willowbrook Playfield

My family and I have been residents of Blackthorn Close near to Willowbrook since 1990.

I always remember my first day as a resident, as I went looking for somewhere to walk my dog, and a neighbour advised that if I went into Willowbrook there was a small Playfield in the corner which I could walk through to gain access to the fields the other side and from there be able to make my way down to the river and the Wye Valley Walk.

Not knowing Greytree well at that time I was so pleased to find such a route from my new home, and have been using this route for dog walks every day since for the past twenty-five years.

When my children grew to an age when they could go out to play, they would also spend long hours in the play area, either with ball games or playing in the trees adjacent to the stream. Prior to Abbotts Close being built, they would also use the play area as a route to the woods, which were then adjacent to the play area.

I know that my children are not alone in using the play area, as it has always provided a very useful recreational area for residents.

Up until last year, the Council always mowed the grass in the play area encouraging residents and their children to use it, and it has only been in the past twelve months with funding cuts (as we know all across Ross on Wye) that grass cutting has been one of the areas where cut backs have effected play areas such as this.

This has not only affected the play area in Willowbrook, but also the Play areas adjacent and behind Blackthorn Close. In Blackthorn Close, as residents, we have all taken it in turns to mow the grass adjacent to our houses, and although I cannot speak for all residents of Blackthorn Close I am sure that a lot of us would be prepared to support the residents of Willowbrook to assist with the maintenance of the Play area in the absence of maintenance by the council, as we would all benefit from its upkeep.

The play areas defined by the original plans for the residential developments by Crouch Homes for Willowbrook and Blackthorn Close (copy attached) clearly show the play areas and confirm that they were an integral part of the residential development, providing play area facilities to support the residents and their children, so that children could play close to their homes. Areas for children to play, so that parents could feel safe in the knowledge that they were not far away but at the same time playing in an outdoor health environment. When we relate to this being defined in 1981 it was quite a forward thinking approach when relating to the needs we define today for residents and children.

I would anticipate that when the roads were created for Willowbrook and Blackthorn Close and were adopted by the council, in the same way that they adopted the maintenance of the roads, drainage and streetlights, they also adopted the maintenance of the play areas.

I have no objection to the ownership of the playfields being taken by a resident adjacent to the original Crouch Homes development, but I would not want to see the playfield be removed as it has provided such a facility and support to the residents not only of Willowbrook and Blackthorn Close but I know it is also used by many other residents of Greytree as well. The original deed associated with the Crouch Homes development (Willowbrook and Blackthorn Close) specifically defined the definition of the play areas associated with the developments and confirmed that these should remain in place for at least 99 years. I would therefore hope that these play areas remain in place, and are allowed to be maintained either by the council or by the residents where they have taken the opportunity to maintain their own environment (as we have in Blackthorn Close) for at least a further 65 years.

I can therefore confirm my full support for all of these particular areas (as defined by the original Crouch Homes development Land Registration) to be given Village Green status.
