## Welcome and Introduction

### Matters arising (all)

Mary queried the lack of a report from the Day Activities Framework review. Glen said the Day Activities Framework review had been completed and they were now looking at the outcome of the review. This includes what things need to be updated and implemented through the

transformation programme which they have been working closely with HAT (Hereford Activities Together) on.

Glen said they do need to update the Day Activities Framework document before resending it out.

### Services Update and Development -Sally Wilson (Interim Head of Care Commissioning) Glen Crosier (Senior Commissioning Officer)

Sally mentioned that she was happy to see the progress that Hayley Doyle and Glen had made working on the Day Activities Framework Review, working with providers to address their concerns prior to her arrival around Easter.

Sally also discussed how Hilary Hall (Corporate Director Community Wellbeing, Community Wellbeing) has been working with her senior management team and wider stake holders to how the Council takes forward a transformative approach to development of services within the community wellbeing directorate. A Transformation Strategy is in development around how the directorate can better support people in their own home to prevent people needing longer term care.

She also said the directorate wanted to take a more co-production approach to developing services by working with partners and providers more closely.

Glen mentioned that there had been work to review community activities and supported living services over the last couple of years.

Glen mentioned they a working on a 12 month timeline that includes assessing outcomes from both the community activities and supported living reviews from now until September before doing a procurement exercise. At which point they will be renewing the approved provider list for community activities and supported living. This will help with reviewing contracts and inviting other types of service providers to the table and help develop and commission different types of services in line with what people want and need.

Glen also said that the Council and Community Wellbeing Directorate was committed to putting in place a co-production plan to look at how services are set up and funded. There has been one meeting so far with the HAT group at the Cart Shed and another co-production day is scheduled in June.

A programme of engagement still needs to be developed in collaboration with this board (LDPB). They are currently working with community activity providers (HAT group), plan to engage with supported living providers and carers, parents and service users.

Glen said they will look back at previous feedback on how community activities could be improved. Glen will share the timetable regarding procurement.

Comments from Sean included making sure the perspectives of individuals at school and colleagues who will coming into day services over the coming years were sort. Mary mentioned the importance of developing a feedback loop and have a bit of transparency.

# Hear Me Now Rosa Murray (Channel 3 Consulting) Lorenzo (Maldaba Ltd) Clare Dauncey (Development and Innovation Manager Maldaba Ltd)

Lorenzo did an overview of the project "Hear Me Now" which was developed by Herefordshire and Worcestershire ICB, Channel 3 Consulting, Maldaba and Academia. The project aims to help people with learning disabilities and autism be more independent. Hear Me Now is app that will work on android and apple devices and helps people capture the information that matters to them using the multimedia format they prefer i.e. video, audio, pictures and links to YouTube. Individuals can share information with the people important in their life such as friends, family carers and professionals through a secure website and these people can share information back with the individual.

The "Hear Me Now" app went live to the public in 2016 and individuals have used the app for a range of different things such as: a food diary; to help manage their health conditions; changes in circumstance and care needs; to help people know what matters to them and as a digital passport.

Since they last presented to the board in February they have been working really hard to engage across the ICB to ensure as many social workers, providers and groups know about the app.

They are current engaged with more than 40 providers or social work teams across the ICB at various stages from the first introductory stages to going though training to start getting individuals using the app.

They current funding from NHS England means it free the end user but in order for this continue they feedback from new users to show it is making a difference.

# Impact of LDPB Surveys Discussion and Sub Group Feedback from the last LDPB Survey Mary Simpson

Mary discussed the feedback from the poll on Changing Places Facilities (see attached). Feedback mentioned the lack of facilities across the county, how the lack of facilities stops people participating in events and the need for more changing places facilities to have a bed as well as a hoist, so individuals don't get changed in an undignified manor on the toilet floor.
