3	Has any part of the work described in an initial notice been carried out and the initial notice has ceased to be in force? If so, Regulation 19 of the Building (Approved Inspectors etc) Regulations 2010 (local authority powers in relation to partly completed work) applies. Compliance should be with the requirements of that regulation and an application for building control approval with full plans is not appropriate.	<u>12(7)</u>	

If the response to all the questions is 'no' then the giving of an application for building control approval with full plans is appropriate for the proposed work. Where the response is 'yes' for row 1, an application should be made to the Building Safety Regulator. Where the response is 'yes' to any other row, an application for building control approval with full plans is not necessary for the work. For work in relation to row 3, please contact the local authority team for your area.

<ul> <li>An application for building control approval with full plans must be accompanied by:</li> <li>two copies of the full plans, or</li> <li>where <u>Part B of Schedule 1</u> (fire safety) imposes a requirement in relation to proposed building work, four copies of the full plans (this does not apply where the proposed building work relates only to the erection, extension or material alteration of a dwelling-house or flat).</li> </ul>	<u>14(2)(a)</u> <u>14(4)</u>

Plans are only full plans if they consist of

- a description of the proposed building renovation or replacement of a thern element, change to the building's en status or material change of use
- the plans, particulars and statements required by paragraphs (1), (1A) and **Regulation 13**

The local authority must notify the application the outcome of the application within five weeks beginning with the date the application is received by the local authority, or withi longer period as at any time the authority applicant agree in writing. If you wish to the period of time that the local authority notify of the outcome of the application, include this request with the application for building control approval with full plans for local authority to consider.

Applicants should be aware that the Loc Authority will as required consult with sta bodies and pass on those details that you submit on your application form for the p of granting the Building Regulations appl Without this data collection, we could not process the application. Applicant details only passed on to the necessary statutor consultees.
