B4214 - From a point 80m north of its junction with the access to Sandown to a point 101m north of its junction with the access to Avenholme, Woodland View & Claypits Farm. **Stoke Lane (C1131)** - From its junction with B4214 for a distance of 104m in an easterly direction.


The extent of the existing 40mph speed limit be reduced to align with the new extent of the 30mph speed limit.
