HEREFORDSHIRE COUNCIL (MABELS FURLONG AND BRAY AVENUE, LEDBURY) (PROHIBITION OF WAITING AT ANY TIME) ORDER 2023

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2 & 3 of Part 1 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce:

No Waiting at Any Time (Double Yellow Line) restrictions on the following lengths of road: Mabels Furlong (Northern Side): From its junction with A449 for a distance of 42m in a westerly direction into the School Access Road to the limit of its adoption. Mabels Furlong (South-Eastern Side): From its junction with A449 to its junction with Bray Avenue. From its junction with Bray Avenue for a distance of 10m in a southerly direction. Mabels Furlong (North-Western Side): From a point 9m south-west of its junction with the School Access Road for a distance of 27m in a north-westerly direction into the School Access Road to the limit of its adoption. Bray Avenue (Northern Side): From its junction with Mabels Furlong for a distance of 12m in an easterly direction.

This Order will come into effect on 16th October 2023.
