## HEREFORDSHIRE COUNCIL (CRUXWELL STREET & ROWBERRY STREET, BROMYARD) (PROHIBITION OF WAITING AT ANY TIME & LIMITED WAITING) ORDER 2023

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2, 3, 4, 5, 32, 33, 35, 37, 45 & 47 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce:

No Waiting at Any Time (Double Yellow Line) restrictions on the following lengths of road:

**Cruxwell Street (North-West Side):** From its point 15m south-west of its junction with Rowberry Street for a distance of 37m in a south-westerly direction.

**Rowberry Street (South-East Side):** From its junction with Church Street for a distance of 19m in a south-westerly direction.

Limited Waiting (Marked Bay) Restriction (Mon-Sat 08:00-18:00, 1 hour, No Return Within 1 Hour) on the following lengths of road:

**Cruxwell Street (South-East):** From a point 9m south-west of its junction with Rowberry Street for a distance of 17m in a south-westerly direction.

**Cruxwell Street (South-East):** From a point 35m south-west of its junction with Rowberry Street for a distance of 16m in a south-westerly direction.

This Order will come into effect on **10<sup>th</sup> November 2023**.
