# NOTICE OF MAKING <br> HEREFORDSHIRE COUNCIL <br> (COLLEGE ROAD \& LEGION WAY, HEREFORD) (PROHIBITION OF WAITING AT ANY TIME) ORDER 2023 

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2 and 3 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce: No Waiting at Any Time (Double Yellow Line) restrictions on the following lengths of road:
College Road (Western Side): From its junction with A4103 Roman Road for a distance of 24 m in a southerly direction.
College Road (Western Side): From a point 8m south of its junction with Legion Way for a distance of 38 m in a southerly direction.
College Road (Western Side): From a point 72m south of its junction with Legion Way for a distance of 44 m in a southerly direction.
College Road (Eastern Side): From its junction with A4103 Roman Road for a distance of 103 m in a southerly direction.
College Road (Eastern Side): From a point $4 m$ south of its junction with Centurion Way for a distance of 106 m in a southerly direction.
Legion Way (Northern Side): From its junction with College Road for a distance of 15 m in a south-westerly direction.
This Order will come into effect on $15^{\text {th }}$ January 2024.
