## NOTICE OF MAKING

## HEREFORDSHIRE COUNCIL (C1185 & BROBURY LANE (U90000), BREDWARDINE) (PROHIBITION OF WAITING AT ANY TIME) ORDER 2023

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2 and 3 of Part 1 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce: No Waiting at Any Time (Double Yellow Line) restrictions on the following lengths of road:

**C1185 (Northern Side):** From the western give way line of its junction with U90000 for a distance of 23m in a westerly direction (to existing restrictions). From a point 53m east of the eastern give way line of its junction with U90000 for a distance of 44m in an easterly direction.

**C1185 (Southern Side):** From its junction with the access to Brobury Gardens for a distance of 112m in a westerly direction (to existing restrictions). From its junction with the access to Brobury Gardens for a distance of 22m in an easterly direction.

**U90000 (Western Side):** From the western give way line of its junction with C1185 for a distance of 44m in a northerly direction.

**U90000 (Eastern Side):** From a point 13m north of the eastern give way line of its junction with C1185 for a distance of 28m in a northerly direction.

**C1185/U90000:** Around the entire extent of the central grass triangle at the junction of C1185/U90000.

This Order will come into effect on **30<sup>th</sup> October 2023**.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service.
