STATEMENT OF REASONS FOR PROPOSING

HEREFORDSHIRE COUNCIL (SPEED LIMIT) (CONSOLIDATION) ORDER 2022 (VARIATION) ORDER No.2 2024 (A4110, CANON PYON) (30MPH SPEED LIMIT)

The implementation of the proposed 30mph speed limit under Section 84 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, is necessary for the following reasons:

- For avoiding danger to persons or other traffic using the road or any other road or preventing the likelihood of any such danger arising.
- For preserving and improving the amenity of the area through which the road runs.
- To improve road safety, especially for parents, children and other pedestrians within the vicinity of the primary school.
- To ensure that the school, which is a main focal point of the village, is covered by a 30mph speed limit.
