#### 1. Introduction

- 1.1 The involvement of communities and stakeholders is key to preparing a Local Plan for Herefordshire which allows it to grow sustainably, meets the needs of our communities, and protects and enhances the things we value most.
- 1.2 The Council works closely with communities and stakeholders in reviewing the Local Plan, carrying out a range of engagement and consultation, including in person event, throughout its preparation.
- 1.3 This document sets out Herefordshire Council's approach to consulting and engaging the community and stakeholders on the next stage of consultation on the Local Plan which is the Regulation 18 Draft Local Plan. The Council seeks to take an inclusive and proactive approach to engagement, providing the opportunity for all to engage in the plan-making process.
- 1.4 The Local Plan has already gone through various stages of consultation. A summary of these stages, along with the timetable going forward is set out in the diagram below.
- 1.5 The principles set out in this document are consistent with the Council's Statement of Community Involvement, which was updated in 2022. We welcome feedback from communities and stakeholders on the content of the Regulation 18 Draft Local Plan.

## 2 Engagement and Consultation

- 2.1 There are a variety of ways in which communities and stakeholders have been involved in the preparation of the Herefordshire Local Plan. The minimum requirements for consultation and engagement are set out in the Council's Statement of Community Involvement. However, the Council is seeking to be much more proactive in engaging with local communities and stakeholders in the preparation of the new Local Plan.
- 2.2 Table 3 further on in the document, sets out a comprehensive engagement strategy for the Local Plan designed to reach out to as many people and groups as possible. The tables contain information relating to:
  - The methods of consultation and engagement proposed at each stage of the plan making process;
  - The stakeholders and community groups to be engaged;
  - The scope of the engagement and consultation; and
  - The desired outputs for each stage of the process.
- 2.3 The engagement process will be carried out through in person events and using online platforms. There are certain organisations and bodies that the Council must consult when preparing plan documents, but we have also reached out to key local groups within the county during the preparation of the local plan. The main groups that have been consulted are:
  - Central, Regional and Local Government organisations
  - Statutory bodies
  - Community, voluntary, resident and interested groups
  - Individuals who have requested to be kept informed on planning policy matters
  - Parish/Town Councils
  - Ward members
  - Local businesses, developers and agents
- 2.4 At the Regulation 18 Draft Local Plan launch event, the proposed engagement and consultation aims to ensure that all interested parties and relevant groups are aware of the launch of the new Draft Local Plan, its context, scope, and the ways in which they can be involved. The Council seeks an understanding of initial views, through consultation on the draft document. Various methods of engagement and consultation shall be used, comprising mail outs, press releases, webinars, consultation questionnaires,
- 2.5 A number of roadshow events will also be held around the county, including

Hereford City, market towns and rural village halls, as well as online meetings. Table 2 shows a schedule of the upcoming roadshow events.

- 2.6 The proposed engagement of the Local Plan preparation (Evidence Gathering, Engagement and Options Formulation) was originally split into two sections. Initially, between January 2022 and February 2023, the Council sought to build a clear understanding of the key issues facing stakeholders and communities, and begin to understand the opportunities that exist across the County to address these issues. We also worked with stakeholders and communities to establish the evidence base required to better understand these issues. Methods of engagement at this stage comprised, targeted meetings and online engagement with parish and town councils, community groups, key stakeholders and landowners. Following this results were published online, including:
  - An update on progress with the preparation of the Local Plan
  - Outcomes from previous engagement sessions
  - A link to any available evidence produced to date
  - Details regarding future engagement sessions
- 2.7 Following the end of the Regulation 18 Draft Local Plan consultation Herefordshire Council will be undertaking a further consultation known as Regulation 19. For information on this, please refer to Figure 1.

## **3** Our Engagement and Communication Website

- 3.1 The Council have used the engagement platform <u>Commonplace</u> alongside the <u>Herefordshire Council</u> website throughout the preparation of the new Local Plan, providing regular updates regarding progress on its preparation. Commonplace has been updated and will continue to be regularly updated, and will comprise the following:
  - A web form to which residents and stakeholders can add their contact details, to sign up to our Commonplace mailing list for the latest updates regarding the Herefordshire Local Plan.
  - A live '<u>evidence base page</u>' is available on the Herefordshire Council website, in which evidence base documents are uploaded as and when they become available.
  - A programme showing key dates in the preparation of the Local Plan.
  - Commonplace and Herefordshire council website, will be updated regularly to include dates and details of public engagement sessions.
  - A number of live 'Call for Sites' webpage providing a space for landowners and interested parties to upload details on potential development sites. This will also include key dates by which potential development sites should be submitted by.

## 4 Alignment with other Council engagement and consultation events

- 4.1 The preparation of the Local Plan will be aligned with the preparation of other relevant strategies for the County, and where possible, engagement and consultation events will also be aligned.
- 4.2 The Planning Policy team have consulted with other services within the Council on a regular basis through an internal document mail out. Officers were asked to provide comments on strategic policy documents to ensure alignment across county visions.

## 5. Ensuring an inclusive consultation

The Council's <u>Statement of Community Involvement</u> sets out all groups with whom the Council will seek to engage directly throughout the preparation of the Local Plan, as summarised below:

**Young people** Children and young people have not traditionally been involved in planning issues. Involvement will be encouraged through initiatives linked to local colleges, schools and youth groups or other voluntary and community organisations. A young person's survey has been included on the Commonplace consultation platform. Secondary schools and colleges across Herefordshire will be emailed with information and instructions on how to view a simplified version of the local plan and how to compete the survey. In person events at Hereford Sixth Form will strengthen the involvement of a younger demographic

**Gypsies and travellers:** We will involve gypsy and traveller groups, particularly as part of the policy evidence gathering process. We will consult members of the gypsy and traveller communities, particularly where issues are of direct relevance.

#### People located in dispersed rural areas.

Residents in more remote rural areas may not have easy access to council offices and may have less access to community events depending on where these are held. Linkages are already in existence with Neighbourhood Plans groups. We aim to build on these established Parish Council networks in order to disseminate information and gather feedback at the most local level possible... The development of e-consultation within the Council will ensure that consultation reaches a wider audience. Information, posters and leaflets will be provided for display on village notice boards and in community libraries and mobile libraries for those who may not have access to the internet.

#### Disabled People including those with numeracy, literacy disabilities

We will seek ideas and feedback from disabled individuals as well as local and national organisations representing disabled people to ensure that community consultation is inclusive and their views are obtained. We will ensure that all community involvement events are fully accessible, and will always respond to any accessibility requests in a positive way by providing Easy Read documents where appropriate

Minority Ethnic and people following different religions or with certain beliefs will be looked at through links with the Council's Equality and diversity team as well as local organisations representing these specific groups.

Older people have generally been active in past consultation responses. There will continue to be links representing local groups supporting the elderly.

Homeless groups there will continue to be links with the Council's Housing Teams as well as local organisations representing this specific group

For young single parents there will be steps to continue to disseminate information through online methods of engagement Local community groups will continue to be contacted to share information

The Strategic and Neighbourhood Planning Team hold an extensive database which lists a wide variety of community groups, businesses and environmental groups. It is frequently updated and anyone can be added to it at any time.

#### 6 Duty to Co-operate

- 4.4 Herefordshire Council has a duty to co-operate on strategic planning issues that cross administrative boundaries and must collaborate with other strategic authorities to identify any relevant strategic matters which need to be addressed.
- 4.5 Cross boundary strategic issues relating to the Local Plan might include issues such as addressing housing need, strategic highway issues, and flooding.
- 4.6 We have liaised with the prescribed duty to co-operate bodies in identifying the cross boundary strategic issues and work jointly with them to address such issues throughout the preparation of the Local Plan, and will continue to do so. The Council will prepare and maintain a Statement of Common Ground documenting the cross boundary matters and progress in co-operation.
- 4.7 A full list of 'duty to co-operate bodies' is set out in Part 2 of the Local Plan Regulations 2012. Herefordshire Council's main duty to co-operate bodies are:
