# Affordable Housing Delivered in the County 2024-2025

Herefordshire Council's Strategic Housing team working in partnership with Registered Providers and private developers have delivered 276 additional affordable properties in the County.

## **The Full Pitcher – Ledbury P/A 194182F**

**Registered Provider – Connexus Housing Group**

**Phase 2 = 60 properties**

The scheme was delivered on land behind the Full Pitcher Public House over two phases and consists of 93 affordable homes for rent, shared ownership and rent to buy.

The properties are subject to a Section 106 which means that they are available to local people in the first instance in perpetuity.

## **Land East of Brook Lane, Bosbury P/A 211480/F**

**Low cost market and Discounted market – Cotswold Oak**

Planning permission was sought to deliver a scheme of 21 properties consisting of 2,3 and 4 bed properties of which 8 were for affordable home ownership.

2 x 2 beds @ 47% discount of open market  
 2 x 3 beds @ 43% discount of open market  
 2 x 2 beds @ 30% discount of open market  
 2 x 3 beds @ 30% discount of open market

The units are subject to a Section 106 which means that they are available to local people in the first instance in perpetuity.

## **Land off Rosemary Lane, Leintwardine**

**Private Developer – Fletcher Homes**

A medium sized planning gain development on the edge of Leintwardine delivering 27 open market and 18 affordable home ownership properties. Phase 1 delivered delivered a total of 4 affordable low cost home ownership (LCHO) properties and 1 LCHO property is reserved. Seven shared equity properties are now being sold on the open market.

The remaining 6 LCHO units will be completed in Phase 2, 25/26

- 3 x 2 Bed - Low Cost Market (discounted by 30%)
- 2 x 3 Bed - Low Cost Market (discounted by 35%)
- 3 x 2 Bed - Shared Equity (20% below open market value)
- 7 x 3 Bed - Shared Equity (20% below open market value)

The development is subject to a Section 106 local connection.

## **Land @ Faraday Road, Madley**

**Private Developer - Bell Homes**

A development of 27 properties, of which 9 are affordable home ownership. The Affordable Houses are a mix of 2 and 3 bedroom and were offered for sale with a 30% discount off the open market value.

The affordable housing consists of:

4 x 2 beds with a discount of 32% off the Open Market Value  
3 x 3 beds with a discount of 35% off the Open Market Value

## **Middleton Avenue Ross-on-Wye P193478/F**

**Registered Provider - Platform Housing**

This development of 44 affordable homes was granted planning permission in June 2021. It is a mix of 1,2 and 3 bedroom properties. Included is a one bedroom bungalow and a two bedroom bungalow. The tenure mix is Affordable Rent and Shared Ownership.
